(3) Drawing No. C-4 - At the end of NOTE 4, delete the period and add "AND SHEET PILE REQUIREMENTS." Also, on both TYPICAL CROSS SECTIONS, delete the NOTE beginning with "SHEET PILE ARBED AZ13 MIN. YIELD. . . ." and substitute the following:

"SHEET PILE. PILE TIP AT -6.0' MTL."

(4) Drawing No. C-4 - On both TYPICAL CROSS SECTIONS, delete all references to "(1-3 TON)," (1/2"-6")," AND "(220-335 LBS)."

(5) Drawing No. C-5 - At the end of NOTE 4, delete the period and add "AND SHEET PILE REQUIREMENTS." Also, on both TYPICAL CROSS SECTIONS, delete the NOTE beginning with "SHEET PILE ARBED AZ13 MIN. YIELD. . . ." and substitute the following:

"SHEET PILE. PILE TIP AT -6.0' MTL."

(6) Drawing No. C-5 - On both TYPICAL CROSS SECTIONS, delete all references to "(1-3 TON)," (1/2"-6")," AND "(220-335 LBS)."

(7) Drawing No. C-9 - On SECTION 7, STA. = 0+350, from STATION 33+000 to STATION 33+300, change the bottom of the sheet pile to read: "-6.0' MTL" and from STATION 33+300 TO STATION 33+540, change the bottom of sheet pile to read: "-12.0' MTL."
