identified on the subject property are surrounded by uplands. Their independent centers are located at 28.702131°, -96.538590° (Wet1) and 28.701967°, -96.539515° (Wet2), respectively. They are both outside of the 100 year floodplain.

The wetlands are surrounded on all 4 sides by uplands with no hydrologic connections to the surrounding areas determined during the site visit. The closest waterbody (Cox Creek Slough) is greater than 2,170 feet away; we also noted that there is an intermittent feature/upland manmade stormwater ditch indicated on the topo map located approximately 560 feet away from the nearest edge of the wetland.

Wetland (Wet1 & Wet 2) have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plains Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which require that, under normal circumstances, an area has a predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support this aquatic ecosystem. These two wetlands totaling appx 1.9 acres in size (Wet1 appx 0.9 acre & Wet2 appx 1 -acre) are located in depressional landscape positions, with mapped soils listed as hydric in flats within Calhoun County Contee-Dacosta Complex (Md) and Telferner Very Fine Sandy Loam (Te). The primary source of hydrology is precipitation. The USGS topographic map (1995) indicates the isolated wetland area is relatively flat between two relatively wide contour lines. The wetlands are outside the 100 year FEMA floodplain as reflected on the Flood Insurance Map. The NWI map indicates two wetlands at this location. They are both identified as (PEM1A) palustrine, emergent, persistent, temporarily flooded. Color and Infrared aerial photos were reviewed and indicate that these wetlands are surrounded by uplands. During the site visit, the perimeters of both wetlands were evaluated to determine if any hydrologic connections to surrounding waters might exist. Substantial precipitation for days before and during the site visit eased the inspection for hydrologic connections. No connections were found. Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies. There are no confined surface hydrologic connections between these wetlands and any potential or known water of the U.S.

In conclusion: Wet1 & Wet2 are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea. They do not cross interstate or tribal boundaries. Wet1 & Wet2 do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. These wetlands are not impoundments of waters of the United States. Wet1 & Wet2 are not, nor were they ever, part of a surface tributary system of previous waters. These wetlands are not adjacent to any other waters previously identified. Wet1 & Wet2 have been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). They are located outside the anticipated high flow of any water of the United States and do not have a confined hydrological surface connection to any water of the United States. Therefore, it is our determination that these are isolated (as per federal regulation) wetlands that do not possess any known nexus to interstate commerce; and as such, are not subject to federal regulation under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The upland trench to the south of the wetlands was identified as not connected during the onsite, but based on how vivid and suspicious it looks in these latest areials, it is being addressed specifically in the file and JD discussions. It is not (yet) a wetland, it is not connected to the wetlands nor is it connected to any other hydrologic feature.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Two distinct wetlands totaling approximately 1.9 acres in size (Wet1 appx 0.9-acre & Wet2 appx 1 acre) identified on the subject property are surrounded by uplands. Their independent centers are located at 28.702131°, -96.538590° (Wet1) and 28.701967°, -96.539515° (Wet2), respectively. They are both outside of the 100 year floodplain. The wetlands are surrounded on all 4 sides by uplands with no hydrologic connections to the surrounding areas determined during the site visit. The closest waterbody (Cox Creek Slough) is greater than 2,170 feet away; we also noted that there is an intermittent feature/upland manmade stormwater ditch indicated on the topo map located approximately 560 feet away from the nearest edge of the wetland.

Wetland (Wet1 & Wet 2) have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plains Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which require that, under normal circumstances, an area has a predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support this aquatic ecosystem. These two wetlands totaling appx 1.9 acres in size (Wet1 appx 0.9 acre & Wet2 appx 1 -acre) are located in depressional landscape positions, with mapped soils listed as hydric in flats within Calhoun County Contee-Dacosta Complex (Md) and Telferner Very Fine Sandy Loam (Te). The primary source of hydrology is precipitation. The USGS topographic map (1995) indicates the isolated wetland area is relatively flat between two relatively wide contour lines. The wetlands are outside the 100 year FEMA floodplain as reflected on the Flood Insurance Map. The NWI map indicates two wetlands at this location. They are both identified as (PEM1A) palustrine, emergent, persistent, temporarily flooded. Color and Infrared aerial photos were reviewed and indicate that these wetlands are surrounded by uplands. During the site visit, the perimeters of both wetlands were evaluated to determine if any hydrologic connections to surrounding waters might exist. Substantial precipitation for days before and during the site visit eased the inspection for hydrologic connections. No connections were found. Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies. There are no confined surface hydrologic connections between these wetlands and any potential or known water of the U.S.

In conclusion: Wet1 & Wet2 are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea. They do not cross interstate or tribal boundaries. Wet1 & Wet2 do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. These wetlands are not impoundments of waters of the United States. Wet1 & Wet2 are not, nor were they ever, part of a surface tributary system of previous waters. These wetlands are not adjacent to any other waters previously identified. Wet1 & Wet2 have been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). They are located outside the anticipated high flow of any water of the United States and do not have a confined hydrological surface connection to any water of the United States. Therefore, it is our determination that these are isolated (as per federal regulation) wetlands that do not possess any known nexus to interstate commerce; and as such, are not subject to federal regulation under Section 404 of the Clean Water Act

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. The unnamed tributary is approximately 2,447 ft in length and 10 ft. wide (0.6 acres) within the project area. This project area contains the upper reaches of an existing unnamed tributary (RPW) further downstream. This unnamed tributary flows into another unnamed tributary (RPW) which flows into Oyster Creek, a TNW. The grassline ephemeral channel retains excess nutrients contained in observed cow manure from being flushed downstream into the unnamed RPW and into Oyster Creek. Oyster Creek at this location is listed on the TCEQ 2012 303d water list for bacteria and depressed dissolved oxygen. The grassline ephemeral tributary retains excess nutrients contained in observed cow manure from being flushed downstream into the unnamed RPW and into Oyster Creek. The grassline tributary provides habitat for crayfish, insects and other invertebrates. Crayfish burrows were observed during the delineation performed by the consultant. During heavy precipitation events, invertebrates located within the channel are transported into another RPW and then eventually into Oyster Creek, a TNW. This tributary (including downstream) provides the breakdown of chemical pollutants from fertilizers used on the pasture and nitrogen fixation and organic biological breakdowns from the cow manure for approximately 0.6 acres of chemical pollutant removal from being discharged into a TCEQ 303d List water. Also, this tributary is located within the 100-floodplain of Oyster Creek, a TNW, providing 0.6 acres of floodplain storage. In conclusion, it is the Corps' opinion that there is sufficient evidence to support the statement that the aquatic resources within this 1 mile relative reach provides a significant nexus (more and speculative or insubstantial) effect upon the chemical, physical, and/or biological integrity of the downstream TNW. As such, they are subject to federal jurisdiction under Section 404 of the Clean Water Act.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The unnamed tributary is approximately 2,447 ft in length and 10 ft. wide (0.6 acres) within the project area. This project area contains the upper reaches of an existing unnamed tributary (RPW) further downstream. This unnamed tributary flows into another unnamed tributary (RPW) which flows into Oyster Creek, a TNW. The grassline ephemeral channel retains excess nutrients contained in observed cow manure from being flushed downstream into the unnamed RPW and into Oyster Creek. Oyster Creek at this location is listed on the TCEQ 2012 303d water list for bacteria and depressed dissolved oxygen. The grassline ephemeral tributary retains excess nutrients contained in observed cow manure from being flushed downstream into the unnamed RPW and into Oyster Creek. The grassline tributary provides habitat for crayfish, insects and other invertebrates. Crayfish burrows were observed during the delineation performed by the consultant. During heavy precipitation events, invertebrates located within the channel are transported into another RPW and then eventually into Oyster Creek, a TNW. This tributary (including downstream) provides the breakdown of chemical pollutants from fertilizers used on the pasture and nitrogen fixation and organic biological breakdowns from the cow manure for approximately 0.6 acres of chemical pollutant removal from being discharged into a TCEQ 303d List water. Also, this tributary is located within the 100-floodplain of Oyster Creek, a TNW, providing 0.6 acres of floodplain storage. In conclusion, it is the Corps' opinion that there is sufficient evidence to support the statement that the aquatic resources within this 1 mile relative reach provides a significant nexus (more and speculative or insubstantial)effect upon the chemical, physical, and/or biological integrity of the downstream TNW. As such, they are subject to federal jurisdiction under Section 404 of the Clean Water Act.
