Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There are eight isolated wetlands (Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y) on the project site totaling approximately 4.77 acres. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. The wetlands are closed depressions surrounded by uplands. Wetland 1Q totals approximately 0.197-acre. Wetland 1S totals approximately 1.069 acres. Wetland 1T totals approximately 0.53-acre. Wetland 1U totals approximately 2.427 acres. Wetland 1V totals approximately 0.118-acre. Wetland 1W totals approximately 0.22-acre. Wetland 1X totals approximately 0.143-acre. Wetland 1Q totals approximately 0.066-acre. The nearest water of the U.S. is an unnamed tributary to West Fork San Jacinto located approximately 0.63-mile southwest of the project site. The nearest TNW is the West Fork San Jacinto River located approximately 1.66 miles southwest of the project site. According to the FEMA floodplain map, the subject wetlands are located outside the 100-year floodplain of any water of the United States. As such, they are located outside the anticipated high flow of any water of the US. Based on data collected during the 14 June 2017 site visit, the report dated 20 July 2017 submitted on behalf of the applicant, and off-site review, it has been verified that none of these wetlands have a confined hydrological surface connection to any water of the United States, nor are they "inseparably bound" to any waters of the United States under normal hydrologic conditions.**

-Based on off-site data and on-site data collected during the site visit conducted 14 June 2017, there are no known hydrological connections between the wetlands and the unnamed tributary to West Fork San Jacinto or any other water of the United States.

-There are no confined surface hydrologic connections between the wetlands (Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y) and any water of the United States.

Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). They are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce. The destruction of the subject wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not subject to the ebb and flow of the daily tide.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y do not cross interstate or tribal boundaries.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not impoundments of a water of the United States.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not part of a surface tributary system of any of the above.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not part of the territorial seas.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. They are located outside of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y have no known nexus to interstate commerce. We determined Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not waters of the United States and are not subject to Section 404 of the Clean Water Act.

In conclusion, it is SWG's draft determination that Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y totaling appx 4.77 acres are "isolated" and lack a nexus to interstate commerce. As such, these wetlands are not waters of the United States subject to Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are eight isolated wetlands (Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y) on the project site totaling approximately 4.77 acres. The wetlands were identified

using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. Wetland 1Q totals approximately 0.197-acre. Wetland 1S totals approximately 1.069 acres. Wetland 1T totals approximately 0.53-acre. Wetland 1U totals approximately 2.427 acres. Wetland 1V totals approximately 0.118-acre. Wetland 1W totals approximately 0.22-acre. Wetland 1X totals approximately 0.143-acre. Wetland 1Q totals approximately 0.066-acre. The nearest water of the U.S. is an unnamed tributary to West Fork San Jacinto located approximately 0.63-mile southwest of the project site. The nearest TNW is the West Fork San Jacinto River located approximately 1.66 miles southwest of the project site. According to the FEMA floodplain map, the subject wetlands are located outside the 100-year floodplain of any water of the United States. As such, they are located outside the anticipated high flow of any water of the US. Based on data collected during the 14 June 2017 site visit, the report dated 20 July 2017 submitted on behalf of the applicant, and off-site review, it has been verified that none of these wetlands have a confined hydrological surface connection to any water of the United States, nor are they “inseparably bound” to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 14 June 2017, there are no known hydrological connections between the wetlands and the unnamed tributary to West Fork San Jacinto or any other water of the United States.

-There are no confined surface hydrologic connections between the wetlands (Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y) and any water of the United States.

Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). They are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce. The destruction of the subject wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not subject to the ebb and flow of the daily tide.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y do not cross interstate or tribal boundaries.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not impoundments of a water of the United States.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not part of a surface tributary system of any of the above.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not part of the territorial seas.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. They are located outside of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States.

-Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y have no known nexus to interstate commerce. We determined Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y are not waters of the United States and are not subject to Section 404 of the Clean Water Act.

In conclusion, it is SWG's draft determination that Wetlands 1Q, 1T, 1S, 1U, 1V, 1W, 1X, and 1Y totaling appx 4.77 acres are "isolated" and lack a nexus to interstate commerce. As such, these wetlands are not waters of the United States subject to Section 404 of the Clean Water Act.
