Summarize rationale supporting conclusion that wetland is "adjacent": The wetlands are located on Mustang Island, a barrier island that is generally oriented in a north south direction surrounded by the Gulf of Mexico to the east, the outlet of Corpus Christi Bay to the north, and Corpus Christi Bay and the mouth of the Nueces River to the west. The wetlands are approximately 0.6 miles from Corpus Christi Bay and occur within the 100-year floodplain of Corpus Christi Bay. In addition, the wetlands are approximately 0.1 mile from the Gulf of Mexico to the east. The wetlands are separated from the Gulf of Mexico by beach dunes. Regulations specify that "[w]etlands separated from other waters of the United States by man-made dikes or barriers, natural river berms, beach dunes, and the like are adjacent wetlands" even if there is not a continuous surface connection.

#### **B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The Corps determined that the 13 aquatic resources identified in the delineation report and the submitted addendum are jurisdictional because they are adjacent (as defined by 33 CFR 328.3(c) and 33 CFR 328(a)(7)) to the Gulf of Mexico and Corpus Christi Bay, both of which are TNWs. This determination is based on our findings that the aquatic resources subject to this AJD are in close proximity to and have a hydrologic connection via the 100-year floodplain to the Gulf of Mexico and Corpus Christi Bay. Therefore, we determined these aquatic resources to be subject to Section 404 of the Clean Water Act. As such, a Department of the Army permit would be required to discharge dredge and/or fill material into these resources. This approved jurisdictional determination will remain valid five (5) years from the date of the final letter, unless new information warrants revisiting or re-issuance prior to the expiration date.

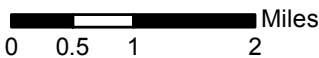
