### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Flow was observed in the tributary during the two site visits (05 March 2015 and 12 September 2015). The tributary receives flow from two water control structures, one that has a flap gate that regulates input from both a waste water control facility and a storm sewer drainage system from a neighborhood. The second water control structure is an overflow dike that drains a regional detention basin that receives water from a channelized tributary. During both site visits, water was flowing into the tributary from both sources. Additionally, aerial photographs (included in the administrative record) submitted by the agent show water in the feature.

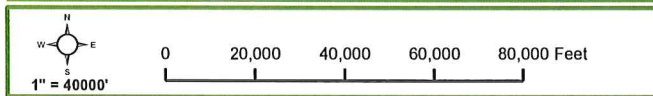

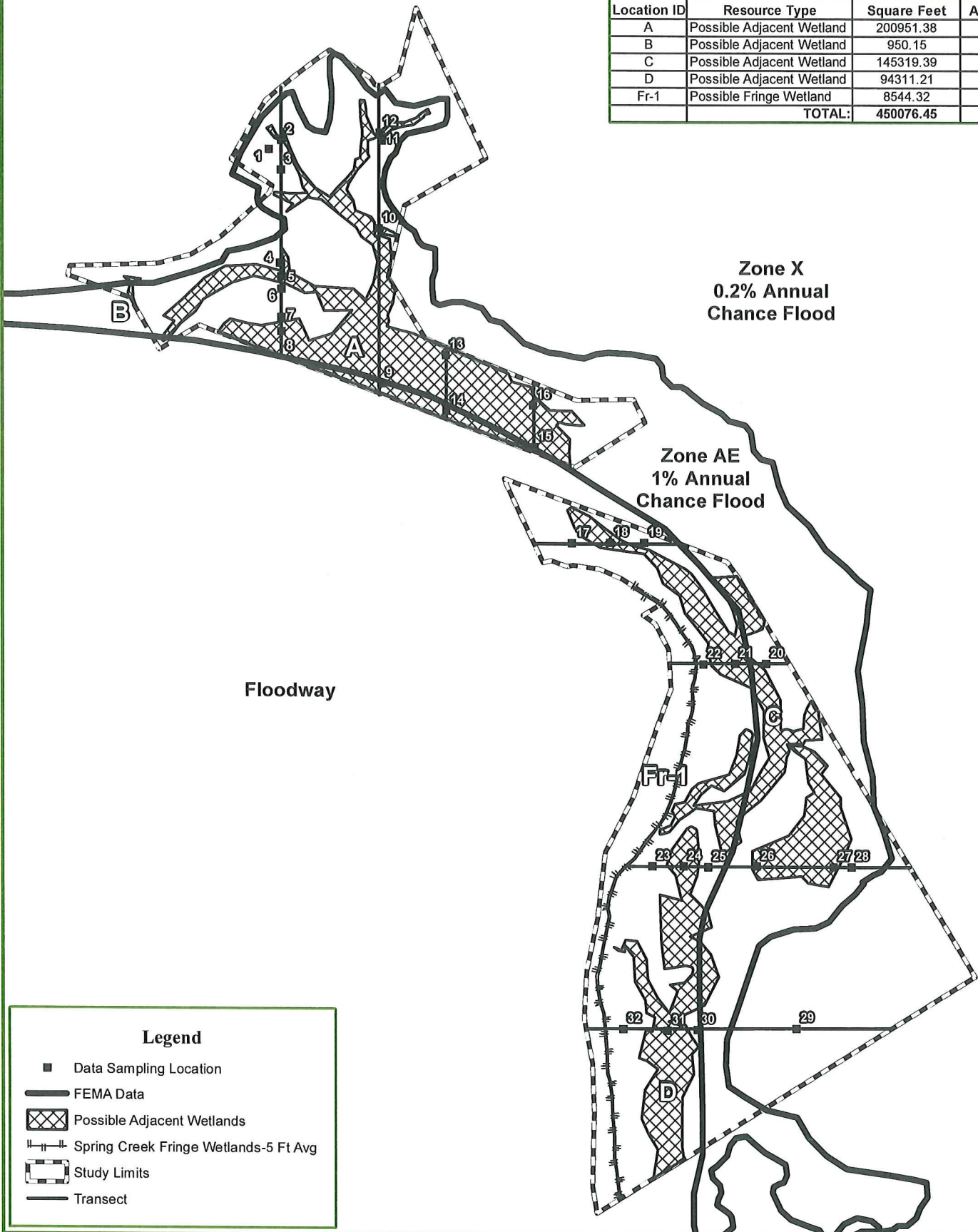

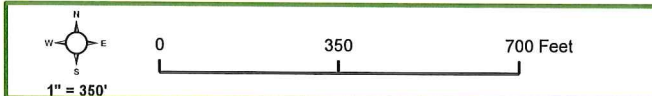

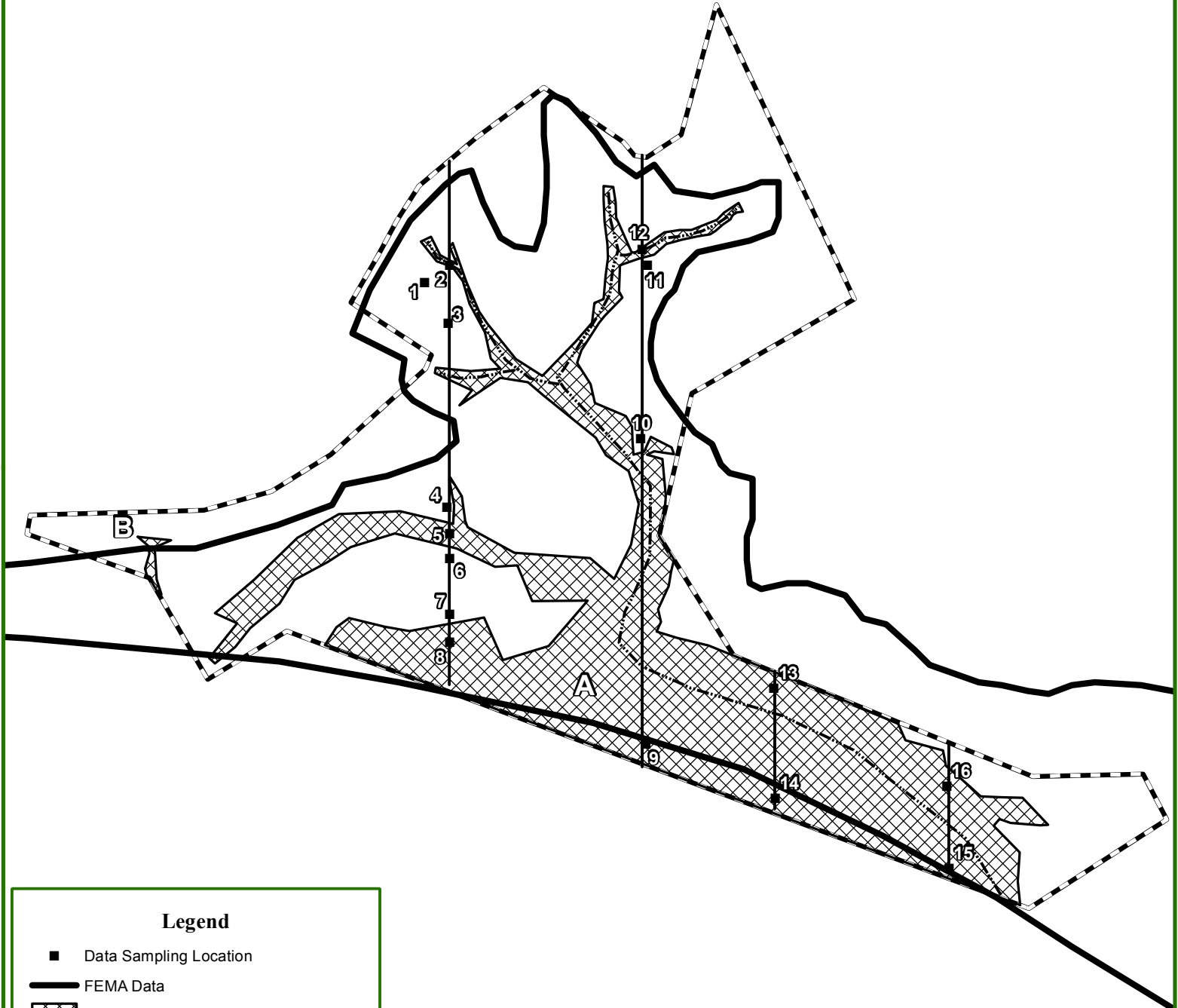
