Summarize rationale supporting determination: The Sabine River is (1) listed on the Galveston District List of Navigable Waters (Section 10 List), (2) is subject to the ebb and flow of the tide, and (3) is presently used, has been used in the past, or may be susceptible for use to transport interstate or foreign commerce. Therefore, per 33 CFR 329.4, the Sabine River is subject to Section 10 of the Rivers and Harbors Act of 1899.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The subject site wetlands are abutting and neighboring, and therefore adjacent to the Sabine River. Therefore, per 33 CFR 328.3(a)(7) the subject site wetlands are subject to jurisdiction under Section 404 of the Clean Water Act.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION
