C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: All of the wetlands on the site are all adjacent to traditional navigable water (Sabine River) and many about the RPW on site. As such the jurisdictional determination will not need to be coordinated with the EPA prior to finalizing the jurisdictional determination. There is a location on the northwestern portion that is very unique as it is a forested site that lacks soils; the entire area has an extremely dense root mass (Peat like) that has water at or near the surface with mature Green Ash, Red Maple and Cyrilla racemiflora.

In conclusion, based upon information provided, offsite data and the site visits combined with federal regulations and guidance we concur that of the 491.4-acres site 476.2-acres are adjacent forested wetlands (see attached map). The site is comprised of six ecotones (assessment areas- five are wetland): AA1 which is 257.3-acres, AA2 which is 26.2-acres, AA3 which is 8.8-acres, AA 4 which is 463.4-acres, and AA 5 which is 120.5-acres and Uplands totaling 15.2-acres
