Summarize rationale supporting conclusion that wetland is "adjacent": Based on the site visit conducted 4 May 2017, wetlands adjacent to Aransas Bay are subject to our jurisdiction and were determined to be located on the subject property. The wetland boundary was verified and sample points were taken utilizing the Atlantic and Gulf Coastal Plain Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. All three wetland criteria were met at a sample point. The subject property is located adjacent to Aransas Bay, which listed on the Galveston District Navigable Waters List.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
