C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetlands in the project area are within the anticipated high flow (100-year floodplain) and, therefore neighbor the Neches River. The 100-year floodplain is an area that experiences a 1% annual anticipated frequency of flooding, which contributes to water exchange. The Neches River is listed on the Galveston District’s Approved List of Navigable Waters, and has a navigable length of 114 miles. Wet 1 and Wet 2 are adjacent to the navigable portion of the Neches River. Therefore, Wet 1 and

Wet 2 are subject to Section 404 of the Clean Water Act, and any discharge of dredged and/or fill material into these adjacent wetlands would require a Department of the Army permit.
