WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 were identified

using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are depressional wetlands with precipitation as the primary source of hydrology.

WET 1 is located approximately 3,200 feet north of Bear Creek, the nearest RPW. WET 2 is approximately 2,900 feet north of Bear Creek. WET 3 is approximately 2,500 feet north of Bear Creek. WET 4 is approximately 2,200 feet north of Bear Creek. WET 5 is approximately 2,100 feet north of Bear Creek. WET 6 is approximately 1,800 feet north of Bear Creek. WET 7 is approximately 1,400 feet north of Bear Creek. WET 8 is approximately 1,400 feet north of Bear Creek. WET 9 is approximately 1,500 feet north of Bear Creek. WET 10 is approximately 1,300 feet north of Bear Creek. There are no known hydrological connections between WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 and Bear Creek. There are no confined hydrological connections between WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 and any water of the U.S. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are isolated and are not waters of the U.S., as defined in 33 CFR 328.3(a). WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not subject to the ebb and flow of the daily tide. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 do not cross interstate or tribal boundaries. The destruction of WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 have been determined not to be “ecologically adjacent”, as defined in the Rapanos guidance as being “reasonably close” such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the U.S. other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. These isolated wetlands are located in a depressional landscape position. The principal source of hydrology is precipitation. Wetlands WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which requires that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support an aquatic ecosystem.

Therefore, WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are isolated, with no known nexus to interstate commerce. As such, WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not subject to federal jurisdiction under Section 404 of the Clean Water Act.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Based on review of available information and the 25 January 201 site visit, we have determined that WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are isolated waters of the United States, as defined in 33 CFR 328.3(a). WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. WET



1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are depressional wetlands with precipitation as the primary source of hydrology.

WET 1 is located approximately 3,200 feet north of Bear Creek, the nearest RPW. WET 2 is approximately 2,900 feet north of Bear Creek. WET 3 is approximately 2,500 feet north of Bear Creek. WET 4 is approximately 2,200 feet north of Bear Creek. WET 5 is approximately 2,100 feet north of Bear Creek. WET 6 is approximately 1,800 feet north of Bear Creek. WET 7 is approximately 1,400 feet north of Bear Creek. WET 8 is approximately 1,400 feet north of Bear Creek. WET 9 is approximately 1,500 feet north of Bear Creek. WET 10 is approximately 1,300 feet north of Bear Creek. There are no known hydrological connections between WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 and Bear Creek. There are no confined hydrological connections between WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 and any water of the U.S. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are isolated and are not waters of the U.S., as defined in 33 CFR 328.3(a). WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not subject to the ebb and flow of the daily tide. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 do not cross interstate or tribal boundaries. The destruction of WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not impoundments of waters of the U.S. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not part of a surface tributary system of any of the above. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not part of the territorial seas. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not adjacent to waters identified in any of the above. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 have been determined by the Galveston District to NOT be adjacent (bordering, contiguous, or neighboring) as defined by 33 CFR 328.3(c). WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are located out of the 100-year floodplain of any water of the U.S. and do not have a confined hydrological surface connection to any water of the U.S. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 have been determined not to be “ecologically adjacent”, as defined in the Rapanos guidance as being “reasonably close” such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the U.S. other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. These isolated wetlands are located in a depressional landscape position. The principal source of hydrology is precipitation. Wetlands WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which requires that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support an aquatic ecosystem.

Therefore, WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are isolated, with no known nexus to interstate commerce. As such, WET 1, WET 2, WET 3, WET 4, WET 5, WET 6, WET 7, WET 8, WET 9, and WET 10 are not subject to federal jurisdiction under Section 404 of the Clean Water Act.
