**SECTION III: CWA ANALYSIS**

Summarize rationale supporting determination: Moses Lake is a tributary of Galveston Bay listed on the Galveston District's List of Navigable Waters, receives the ebb and flow of the daily tide, and is traversed daily by recreational and commercial boaters and fisherman.

Summarize rationale supporting conclusion that wetland is “adjacent”: The 0.04 acre of wetlands located on the subject tract were created due to alteration of the property and adjacent properties for the construction of a levee and subsequent residential development. The property historically had wetlands prior to the manipulation of the substrate and elevational changes. During the past, these wetlands drained directly into Moses Lake (based on historic topographic maps and aerial photography reviewed 1995 and earlier). However, the property was then ditched or raised depending on location, altering the natural sloping grade toward Moses Lake and creating these non-tidal, depressional, linear wetlands. Based on the historical characteristics of the property visible on aerial imagery and the proximity of the wetlands to Moses Lake (within 75 linear feet from the shoreline), as well as their location within the floodplain, the wetlands have been determined to be adjacent (neighboring) to Moses Lake.

**B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
