- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetland A is an appx 8 wetland that is in the central western portion of the site. It also contains a small ways in both direction along the ditch parralleling the rail road tracks along the western property boundary. (NOTE this ditch does not continue to any waterway and has upland wihtin it -thus making this small area lentic. The linear depression becomes an upland manmade drainage ditch north and south of Wetland A.) Wetland A is also located approximately 1,600 feet west and

southeast of Oyster Creek, a TNW at this location. Wetland B is approximately 80 feet from the upland man made drainage ditch and approximately 600 feet southeast of Oyster Creek. There are no known surface hydrologic connections under normal conditions between Wetland A or B and the upland manmade drainage ditch to Oyster Creek, the nearest TNW. There are no confined hydrological connections between Wetlands A or B and any water of the U.S. Wetlands A and B are isolated and are not waters of the U.S., as defined in 33 CFR 328.3(a). Wetlands A and B are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. There is no known nexus between Wetlands A and B and the nearest TNW (Oyster Creek). Wetlands A and B are not subject to the ebb and flow of the daily tide. Wetlands A and B do not cross interstate or tribal boundaries. The destruction of Wetlands A and B (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. Wetlands A and B are not impoundments of waters of the U.S. Wetlands A and B are not part of a surface tributary system of any of the above. Wetlands A and B are not part of the territorial seas. Wetlands A and B are not adjacent to waters identified in any of the above. Wetlands A and B have been determined by the Galveston District to NOT be adjacent (bordering, contiguous, or neighboring) as defined by 33 CFR 328.3(c). Wetlands A and B are located out of the 100-year floodplain of any water of the U.S. and do not have a confined hydrological surface connection to any water of the U.S. Wetlands A and B are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. Wetlands A and B have been determined not to be “ecologically adjacent”, as defined in the Rapanos guidance as being “reasonably close” such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the U.S. other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. These isolated wetlands are located in a depressional landscape position. The principal source of hydrology is precipitation. Wetlands A and B have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which requires that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support an aquatic ecosystem.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland A is an appx 8 wetland that is in the central western portion of the site. It also contains a small ways in both direction along the ditch parralleling the rail road tracks along the western property boundary. (NOTE this ditch does not continue to any waterway and has upland within it -thus making this small area lentic. The linear depression becomes an upland manmade drainage ditch north and south of Wetland A.). Wetland A is also located approximately 1,600 feet west and southeast of Oyster Creek, a TNW at this location. Wetland B is approximately 80 feet from the upland man made drainage ditch and approximately 600

feet southeast of Oyster Creek. There are no known hydrologic connections between Wetland A or B and the upland manmade drainage ditch to Oyster Creek, the nearest TNW. There are no confined hydrological connections between Wetlands A or B and any water of the U.S. Wetlands A and B are isolated and are not waters of the U.S., as defined in 33 CFR 328.3(a). Wetlands A and B are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. There is no known nexus between Wetlands A and B and the nearest TNW (Oyster Creek). Wetlands A and B are not subject to the ebb and flow of the daily tide. Wetlands A and B do not cross interstate or tribal boundaries. The destruction of Wetlands A and B (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. Wetlands A and B are not impoundments of waters of the U.S. Wetlands A and B are not part of a surface tributary system of any of the above. Wetlands A and B are not part of the territorial seas. Wetlands A and B are not adjacent to waters identified in any of the above. Wetlands A and B have been determined by the Galveston District to NOT be adjacent (bordering, contiguous, or neighboring) as defined by 33 CFR 328.3(c). Wetlands A and B are located out of the 100-year floodplain of any water of the U.S. and do not have a confined hydrological surface connection to any water of the U.S. Wetlands A and B are isolated wetlands as defined in 33 CFR 330.2(e); those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. Wetlands A and B have been determined not to be “ecologically adjacent”, as defined in the Rapanos guidance as being “reasonably close” such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the U.S. other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. These isolated wetlands are located in a depression landscape position. The principal source of hydrology is precipitation. Wetlands A and B have been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which requires that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support an aquatic ecosystem.

Therefore, the subject wetlands are isolated, with no known nexus to interstate commerce. As such, Wetlands A and B are not subject to federal jurisdiction under Section 404 of the Clean Water Act.
