C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is located in the Flour Bluff area of Corpus Christi, just south of Waldron Field; the lot is approximately 20 acres in size. In the 1950's the area consisted of prairie and grasslands before being used as a borrow pit for the development of the surrounding residential and commercial area. Excavation began in the 1960's and continued till approximately 2010 according to historical aerial photos. According to the project plans submitted by the applicant the project site is located on the northwest corner of the property totaling 2.25 acres. The National Wetland Inventory shows the project site as Palustrine,

Unconsolidated Bottom, Permanently Flooded, Excavated (PUBHx), the area is not in a flood zone according to the aforementioned FEMA map. The aerial photography's shows that the last time the project site had any surface water present was in 2010, in 2011 the site was converted to upland. Since 2011 the area has naturalized, displaying upland characteristics as seen in site visit on 20 December 2016. The wetland determination on the project site did not meet the three mandatory criteria for classification of a wetland as per the 1987 Corps of Engineers Wetland Delineation Manual. Therefore it is not considered a water of the U.S. as per 33 CFR 328.3.
