C. PROJECT LOCATION AND BACKGROUND INFORMATION: The project alignment is within the Choate Road right of way. The project begins approximately 1,000 feet west of the intersection of Choate Road and Bay Area Boulevard and ends approximately 0.2 miles east of the intersection of Choate Road and State Highway 146. The project area contains a combination of 4 lane divided boulevard and 2-lane roadways with associated roadside ditches manmade ditches along an associated railroad line, HCFCD Unit A104-07-00, and large drainage feature that divides the 4-lane road section. This project will realign the existing roadway and create a 4-lane boulevard for the entire length of the existing road alignment and will realign 0.2 miles of 2 lane (the section west of Bay Area Boulevard) road to match the existing roadway alignment.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
