Port Bay is a tidal influenced waterbody that flows into Copano Bay, which flows into Aransas Bay, which is connected to the Gulf of Mexico via the Lydia Anne and Corpus Christi Ship Channels. The mean high water and annual high tide lines of Port Bay were mapped within the review area.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The applicant indicates that the review area (i.e. the property boundary) consists of 1.41 acres. Approximately 0.61 acre occurs on dry land, and approximately 0.80 acre occurs within jurisdictional areas. Per 33 CFR 328.4, the limits of jurisdiction within tidal waters of the US extends to the high tide line. Per 33 CFR 328.3(d), the high tide line is the line of intersection of the land with the water's surface at the maximum height reached by a rising tide (i.e. annual high tide line). Both the 0.10 acre of mud flat and the 0.40 acre of emergent wetland identified within the review area occur within the annual high tide line of Port Bay. Therefore, the mud flat qualifies as a water of the US per 33 CFR 328.3(a)(1) and (3). The mud flat also meets all of the criteria listed in 40 CFR 230.42, and as such, qualifies as a special aquatic site. As discussed previously in Section III.A.2, the wetland identified within the review area is contiguous with Port Bay and qualifies as a water of the US per 33 CFR 328.3(a)(1) and (7). Approximately 0.30 acre of the review area occurs within Port Bay, which qualifies as a water of the US per 33 CFR 328.2(a)(1).
