C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 0.4-acre review area consists of an existing roadway (Earling Road), a concrete-lined irrigation ditch (identified by L&G Engineering as Alamo Main), and adjacent mowed and maintained herbaceous roadway right-of-way. Per Regulatory Guidance Letter 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. “run-off” from irrigation) away from irrigated lands. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the United States. The irrigation ditch that traverses the review area is a man-made canal, not influenced by the tides, was excavated in uplands, and serves as part of the Hidalgo County Irrigation District system.

Based on the supporting data, as detailed above, the Corps has determined that the feature identified within the review area qualifies as an irrigation ditch, and as such, is not a water of the U.S. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 1.4-acre review area consists primarily of four artificially excavated ditch features, with a residential neighborhood to the east and agricultural fields to the west. Three of the identified ditch/canal features are oriented southwest to northeast within the review area, and the fourth ditch runs west to east, parallel to East Nolana Loop Road. The fourth ditch primarily serves to convey irrigation related flows from the adjacent agricultural fields into the irrigation canal system, but would also serve to carry excess rainflow runoff into the canal system. Per Regulatory Guidance Letter 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. “run-off” from irrigation) away from irrigated lands. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the United States. The four ditches that were identified within the review area are man-made, are not influenced by the tides, were excavated in uplands, and serve as part of the Hidalgo County Irrigation and Drainage Districts systems.

Based on the supporting data, as detailed above, the Corps has determined that the four features identified within the review area qualify as irrigation ditches, and as such, are not waters of the U.S. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 3.5-acre review area consists primarily of two, artificially excavated ditch features, with agricultural fields to the east and west. Both features are oriented south to north within the review area. Per Regulatory Guidance Letter 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. “run-off” from irrigation) away from irrigated lands. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the United States. The two ditches that were identified within the review area are man-made, are not influenced by the tides, were excavated in uplands, and serve as part of the Hidalgo County Drainage District and Donna Irrigation District systems.

Based on the supporting data, as detailed above, the Corps has determined that the two features identified within the review area qualify as irrigation ditches, and as such, are not waters of the U.S. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 10.7-acre review area consists primarily of Mile 11 1/2 Road right-of-way and an artificially excavated ditch feature located on the north side of the road, which runs parallel to the roadway. Adjacent land consists of residential neighborhoods, agricultural fields, and the Rio Grande Valley Landfill. Per Regulatory Guidance Letter (RGL) 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. “run-off” from irrigation) away from irrigated lands. RGL 07-02 also states that, if a ditch carries only irrigation water, irrigation return flows, and overland flow (precipitation) that moves from an irrigated field either to or away from an area subject to irrigated agriculture (e.g. an irrigated field), that ditch would be considered an irrigation ditch, not a drainage ditch. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the United States. The ditch identified within the review area is man-made, is not influenced by the tides, was excavated in uplands, and primarily serves as part of the Donna Irrigation District System.

Based on the supporting data, as detailed above, the Corps has determined that the two features identified within the review area qualify as irrigation ditches, and as such, are not waters of the U.S. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 1.3-acre review area consists primarily of three, artificially excavated ditch-features (L&G Engineering identified one as Weslaco North Lateral) and agricultural fields. Adjacent land consists of residential neighborhoods and agricultural fields. Per Regulatory Guidance Letter (RGL) 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. “run-off” from irrigation) away from irrigated lands. RGL 07-02 also states that, if a ditch carries only irrigation water, irrigation return flows, and overland flow (precipitation) that moves from an irrigated field either to or away from an area subject to irrigated agriculture (e.g. an irrigated field), that ditch would be considered an irrigation ditch, not a drainage ditch. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the United States. The three ditch features identified within the review area are man-made, are not influenced by the tides, were excavated in uplands, and serve as part of the Harlingen-Cameron County Drainage and Irrigation Districts systems.

Based on the supporting data, as detailed above, the Corps has determined that the three features identified within the review area qualify as irrigation ditches, and as such, are not waters of the U.S. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 3.4-acre review area consists primarily of an artificially excavated ditch feature and adjacent agricultural fields. Per Regulatory Guidance Letter (RGL) 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. “run-off” from irrigation) away from irrigated lands. RGL 07-02 also states that, if a ditch carries only irrigation water, irrigation return flows, and overland flow (precipitation) that moves from an irrigated field either to or away from an area subject to irrigated agriculture (e.g. an irrigated field), that ditch would be considered an irrigation ditch, not a drainage ditch. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land to be waters of the United States. The ditch-feature identified within the review area is man-made, is not influenced by the tides, was excavated in uplands, and serves as part of the Harlingen-Cameron County Drainage District system.

Based on the supporting data, as detailed above, the Corps has determined that the feature identified within the review area qualifies as an irrigation ditch, and as such, is not regulated as a water of the U.S. under Section 404 of the Clean Water Act. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.

C. SIGNIFICANT NEXUS DETERMINATION

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximately 7.7-acre review area consists primarily of an artificially excavated ditch-feature and adjacent agricultural fields. Per Regulatory Guidance Letter (RGL) 07-02, an irrigation ditch is defined as a man-made feature and/or an upland swale that either conveys water to an ultimate irrigation use or place of use, or that moves and/or conveys irrigation water (e.g. "run-off" from irrigation) away from irrigated lands. RGL 07-02 also states that, if a ditch carries only irrigation water, irrigation return flows, and overland flow (precipitation) that moves from an irrigated field either to or away from an area subject to irrigated agriculture (e.g. an irrigated field), that ditch would be considered an irrigation ditch, not a drainage ditch. In addition, pursuant to the 1986 Preamble (51 Federal Register 41217, 13 Nov 1986), the Corps generally does not consider non-tidal drainage and irrigation ditches excavated on dry land, or artificially irrigated areas which would revert to upland if the irrigation ceased, to be waters of the United States. The ditch-feature identified within the review area is man-made, is not influenced by the tides, was excavated in uplands, and serves as part of the Harlingen-Cameron County Irrigation District System. Although the NWI map indicates that wetland features may be present within the ditch-feature, even if present, these wetlands did not exist prior to excavation of the ditch feature, were created as a result of artificial agricultural related irrigation practices, and would revert to uplands if irrigation ceased. Therefore, if present, these wetlands are not considered waters of the U.S., even when augmented on occasion by precipitation.

Based on the supporting data, as detailed above, the Corps has determined that the feature identified within the review area qualifies as an irrigation ditch, and as such, is not regulated as a water of the U.S. under Section 404 of the Clean Water Act. Therefore, the Corps has determined that there are no aquatic resources or potential aquatic resources within this review area that exhibit lateral limits of jurisdiction (e.g. OHWM) or would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides.
