- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

**There are four potential aquatic features located within the proposed project boundary: the Edinburg Main Drainage Canal, the North Central Drainage Ditch, an unnamed earthen drainage feature, and an unnamed concrete irrigation canal.**

**The Edinburg Main Drainage Canal has water pumped into it from the Rio Grande in Pecos, TX for citrus orchard irrigation and water supply throughout the McAllen metropolitan area. It is upstream from the Rio Grande, a TNW, which would not affect the downstream chemical, physical, and biological functions of the TNW. This canal terminates in a series of smaller irrigation canals that eventually terminate completely. This canal was excavated out of uplands for the purposes of irrigation and water supply and is not a water of the United States (US).**

**The North Central Drainage Ditch main water source, other than precipitation, is an outfall from a water treatment facility. This ditch does not have a surface water connection to any downstream TNW. This ditch is for storm water retention and wastewater discharge. This ditch was excavated out of uplands and is not a water of the US.**

**The unnamed earthen drainage feature is a small ditch parallel and along the north side of the Edinburg East Main Canal. It appears to function to collect local drainage for detention. It does not share a surface water connection to any downstream TNW. This ditch was excavated from uplands and is not a water of the US.**

**The unnamed concrete irrigation canal is located completely within uplands within the study area. This canal is managed by the Hidalgo County Irrigation District #1 as an irrigation canal, and has a series of gates to regulate flow. The canal disappears into a subsurface culvert or pipe system with a gate approximately 1.6 miles east of the study area. This canal does not share a surface water connection to any downstream TNW and is not a water of the US.**

**We have determined the four potential aquatic features are not waters of the US and are not subject to jurisdiction pursuant to either Section 10 of the Rivers and Harbors Act of 1899 or Section 404 of the Clean Water Act.**

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

There are four potential aquatic features located within the proposed project boundary: the Edinburg Main Drainage Canal, the North Central Drainage Ditch, an unnamed earthen drainage feature, and an unnamed concrete irrigation canal.

The Edinburg Main Drainage Canal has water pumped into it from the Rio Grande in Penitas, TX for citrus orchard irrigation and water supply throughout the McAllen metropolitan area. It is upstream from the Rio Grande, a TNW, which would not affect the downstream chemical, physical, and biological functions of the TNW. This canal terminates in a series of smaller irrigation canals that eventually terminate completely. This canal was excavated out of uplands for the purposes of irrigation and water supply and is not a water of the United States (US).

The North Central Drainage Ditch main water source, other than precipitation, is an outfall from a water treatment facility. This ditch does not have a surface water connection to any downstream TNW. This ditch is for storm water retention and wastewater discharge. This ditch was excavated out of uplands and is not a water of the US.

The unnamed earthen drainage feature is a small ditch parallel and along the north side of the Edinburg East Main Canal. It appears to function to collect local drainage for detention. It does not share a surface water connection to any downstream TNW. This ditch was excavated from uplands and is not a water of the US.

The unnamed concrete irrigation canal is located completely within uplands within the study area. This canal is managed by the Hidalgo County Irrigation District #1 as an irrigation canal, and has a series of gates to regulate flow. The canal disappears into a subsurface culvert or pipe system with a gate approximately 1.6 miles east of the study area. This canal does not share a surface water connection to any downstream TNW and is not a water of the US.

We have determined the four potential aquatic features are not waters of the US and are not subject to jurisdiction pursuant to either Section 10 of the Rivers and Harbors Act of 1899 or Section 404 of the Clean Water Act.
