C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Per 33 CFR 238.3(a)(8), these features are not waters of the U.S. Based on a review of the supporting data listed above, we have determined that there are no other aquatic resources or potential aquatic resources in the review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. Since there are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics, the Corps determined that there are no waters of the U.S. within the review area.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Approximately 0.2 acre of waste water treatment ponds occurs within the approximately 1.4-acre Site 2 review area. Per 33 CFR 238.3(a)(8), these features are not waters of the U.S. Based on a review of the supporting data listed above, we have determined that there are no other aquatic resources or potential aquatic resources in the review area that would warrant the application of a wetland delineation, significant nexus analysis, navigability determination, or delineation of the ebb and flow of the tides. Since there are no features that exhibit lateral limits of jurisdiction (e.g. OHWM) or wetland characteristics, the Corps determined that there are no waters of the U.S. within the review area.
