SECTION II: SUMMARY OF FINDINGS

A. RHA SECTION 10 DETERMINATION OF JURISDICTION.

There **Are** "navigable waters of the U.S." within Rivers and Harbors Act (RHA) jurisdiction (as defined by 33 CFR part 329) in the review area. [**Required**]

Explain: The review area is located within an artificial canal system that is directly connected to Redfish Bay, which is directly connected to Aransas Bay via the Gulf Intracoastal Waterway (GIWW). These waters are subject to the ebb and flow of the tide as evident by the presence of a high water mark on the existing bulkhead and adjacent piers/docks. Due to the current use of these waters for commercial, industrial, and recreational navigation, both Redfish Bay and Aransas Bay are listed on the Galveston District List of Navigable Waters (Section 10 List). The GIWW is the primary means for transportation of interstate/foreign commerce through these bay systems. Based on these findings, the review area is a navigable water of the U.S. and is subject to Corps jurisdiction under Section 10 of the RHA.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: In addition to the jurisdictional canal system (described in Section II.A., II.B., and Section III.A above), the applicant identified two drainage ditches within the action area, and identified one as a potentially jurisdictional aquatic resource. The drainage ditches occur on each side of Gray Barnum Drive. The ditches lack indications of an ordinary high water mark (i.e. sediment sorting, wracking, change in plant community, and scour), which if present would establish the upper limit of potential jurisdiction of a non-wetland feature (e.g., ephemeral ditch). Based on a desktop review of the supporting data (as detailed above), it was determined that the drainage ditches were excavated in dry land, drain only uplands, only convey water from the road and surrounding area during rainfall events, and do not carry a relatively permanent flow of water. Therefore, these features do not meet the definition of waters of the United States (33 CFR Part 328.3). In addition, these features were determined not to be waters of the US, in accordance with the 1986 Final Rule for Regulatory Programs of the Corps of Engineers (51 Federal Register 219) preamble; therefore, these drainage ditch features identified within the review area are not under Corps jurisdiction.
