SECTION III: CWA ANALYSIS

Summarize rationale supporting conclusion that wetland is “adjacent”: The adjacent wetland is hydrologically connected directly into the San Antonio River. In addition, the wetland lies within the 1% annual flood risk zone (100-year floodplain) of the San Antonio River. Aerial imagery shows connectivity of the wetlands into the San Antonio River. National Wetland Inventory mapper indicates that these wetlands are freshwater forested/shrub wetlands with direct connectivity into the San Antonio River. USDA Web Soil Survey shows indicated the wetlands Trinity Clay that are frequently flooded with a 66-99 percent hydric soils rating. Therefore, per 33 CFR 328.3(c) the wetland is adjacent to the San Antonio River and subject to jurisdiction under Section 404 of the Clean Water Act.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
