Explain: There are seven isolated wetlands (Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G) on the project site totaling appx. 9 acres (see table). The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which

requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. The nearest water of the United States is Big Gulch. According to the FEMA floodplain map, all of the subject wetlands are located within the 100-year floodplain. However, the aquatic feature the floodplain is associated with is a non-tidal, upland man-made drainage ditch (UMMD). The UMMD is not a reroute of a tributary and does not extend the ordinary high water mark (OHWM) of a tributary. Therefore, the unnamed ditch is not a water of the United States. Thus Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are located outside the anticipated high flow of any water of the United States, do not have a confined hydrological surface connection to any water of the United States, and are not "inseparably bound" to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 15 February 2018, there are no known hydrological connections between Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G and Big Gulch or any other water of the United States.

-There are no confined surface hydrologic connections between Wetland A, Wetland B, Wetland C, Wetland D, Wetland F, and Wetland G and any water of the United States.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). They are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce. The destruction of these subject wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not subject to the ebb and flow of the daily tide. -Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G do not cross interstate or tribal boundaries. -Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not impoundments of a water of the United States.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not part of a surface tributary system of any of the above.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not part of the territorial seas. -Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. They are all located outside of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States.

-The wetlands have no known nexus to interstate commerce. We determined the wetlands are not waters of the United States and are not subject to Section 404 of the Clean Water Act.

-Four non-tidal, UMMDs (Ditches 1, 2, 3, & 4) were observed on the site. These features are not reroutes of a tributary. They do not extend the OHWM of a tributary either. Therefore, these ditches are not waters of the United States and are not subject to Section 404 of the Clean Water Act.

-Detention Ponds 1, 2, and 3 were observed during the site visit. No data points were collected in these features, but they appear to be aquatic resources. These feature were artificially created by excavating dry land. They function as settling basins as part of a stormwater drainage system for the Imperial Forest development in compliance with Section 402 of the Clean Water Act. Therefore, Detention Ponds 1, 2, and 3 are waste treatment systems designed to meet the requirement of the Clean Water Act. As such, they are excluded from the definition of waters of the United States under 33 CFR 328.3(a)(8). Detention Ponds 1, 2, and 3 are non-jurisdictional and not subject to Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are seven isolated wetlands (Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G) on the project site totaling appx. 9 acres (see table). The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual, which

requires a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils, under normal conditions. The nearest water of the United States is Big Gulch. According to the FEMA floodplain map, all of the subject wetlands are located within the 100-year floodplain. However, the aquatic feature the floodplain is associated with is a non-tidal, UMMD. The UMMD is not a reroute of a tributary and does not extend the OHWM of a tributary. Therefore, the unnamed ditch is not a water of the United States. Thus Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are located outside the anticipated high flow of any water of the United States, do not have a confined hydrological surface connection to any water of the United States, and are not "inseparably bound" to any waters of the United States under normal hydrologic conditions.

-Based on off-site data and on-site data collected during the site visit conducted 15 February 2018, there are no known hydrological connections between Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G and Big Gulch or any other water of the United States.

-There are no confined surface hydrologic connections between Wetland A, Wetland B, Wetland C, Wetland D, Wetland F, and Wetland G and any water of the United States.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). They are not currently used, were not used in the past, nor are they susceptible to use for interstate or foreign commerce. The destruction of these subject wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

-Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not subject to the ebb and flow of the daily tide. -Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G do not cross interstate or tribal boundaries. -Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not impoundments of a water of the United States.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not part of a surface tributary system of any of the above.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not part of the territorial seas. -Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are not adjacent (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c) to any waters of the U.S.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require any of the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

-Wetland A, Wetland B, Wetland C, Wetland D, Wetland E, Wetland F, and Wetland G are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. They are all located outside of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States.

-The wetlands have no known nexus to interstate commerce. We determined the wetlands are not waters of the United States and are not subject to Section 404 of the Clean Water Act.

-In conclusion, it is SWG's draft determination that these seven wetlands on the tract totaling appx. 9 acres are "isolated" and lack a nexus to interstate commerce. As such, these wetlands are not waters of the United States subject to Section 404 of the Clean Water Act.

-Four non-tidal, UMMDs (Ditches 1, 2, 3, & 4) were observed on the site. These features are not reroutes of a tributary. They do not extend the OHWM of a tributary either. Therefore, these ditches are not waters of the United States and are not subject to Section 404 of the Clean Water Act.

-Detention Ponds 1, 2, and 3 were observed during the site visit. No data points were collected in these features, but they appear to be aquatic resources. These feature were artificially created by excavating dry land. They function as settling basins as part of a stormwater drainage system for the Imperial Forest development in compliance with Section 402 of the Clean Water Act. Therefore, Detention Ponds 1, 2, and 3 are waste treatment systems designed to meet the requirement of the Clean Water Act. As such, they are excluded from the definition of waters of the United States under 33 CFR 328.3(a)(8). Detention Ponds 1, 2, and 3 are non-jurisdictional and not subject to Section 404 of the Clean Water Act.
