C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Resaca de la Palma is depicted on the USGS Quadrangle and NWI topographical maps for East Brownsville, Texas as a perennial stream; therefore, it is a relatively permanent water. A review of historical aerial photography on Google Earth shows the presence of water at the site back to 1950. Water from the Rio Grande is pumped into the resaca for irrigation needs. The resaca is now managed according to water demand (withdrawals) or water surpluses (releases); however, man-made retention structures hold water in the resaca for extended period of time and create lacustrine conditions. The resaca is also used as a relief drainage system to convey floodwaters or released irrigation water in anticipation of an oncoming tropical storm. The resaca provides freshwater habitat for water fowl, and also enhances diversity by providing brushy habitat, cover, drinking water, and exploitable food chains for wildlife and aquatic species. In addition, vegetation associated with this water can provide cover for jaguarundis and ocelots using riparian corridors. The Resaca de la Palma has a historical connection to Sabanitas Lake, which lies within one mile of the Rio Grande. The resaca has a direct hydrologic connection to San Martin Lake, an TNW that has a direct hydrologic connection to the Brownsville Ship Channel (BSC). The BSC is recognized by the USACE Galveston District as a TNW that connects to the Gulf of Mexico.

It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to transfer nutrients and organic carbon that support downstream foodwebs?
- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?
