Explain: **Wetland conditions formed within a Wockley-Gessner Loam soil formation, outside of the 100 year floodplain. The area is surrounded on all sides by uplands. The principal hydrology is precipitation and has no direct**

surface hydrologic connection to any water of the U.S. The closest identified intermittent feature to the wetland that is mapped on the 1977 topo is in a higher landscape position than the wetland. This mapped feature is approximately 1,202 feet away from the nearest edge of this wetland. There is also a road and an upland hay field separating the wetland from the intermittent feature. Wet 1 is located approximately 4,600 feet from Willow Creek, the nearest confirmed Water of the United States.

Wetland (Wet 1) has been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plains Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which require that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support this aquatic ecosystem. This 2.3 acre wetland (Wet 1) is located in a depressional landscape position, with an underlying hydric soil (mapped as Wockley Fine Sandy Loam). The primary source of hydrology is precipitation. The 1916 USGS topographic map does not indicate any waters at this location or in the immediate vicinity of this location. The 1977 topo also does not indicate any waters at this location, but does indicate a mapped intermittent hydrologic feature located to the northwest of the project area, approximately 1,202 feet away from the nearest edge of this wetland on the northwest side of Boudreaux Road. There is no confined surface hydrologic connection between the wetland and the intermittent feature. The wetland is above the 100 year FEMA floodplain as reflected on the Flood Insurance Map; it is mapped as Zone "X". The NWI map indicates the wetland as PEM1A; indicating the source of hydrology is Palustrine (ponded). Infrared aerial photos were reviewed and indicate that this wetland is located in a receiving (lower) landscape position and it is surrounded by uplands; the uplands are located higher in elevation. The 28 July 2012, site visit confirmed the offsite data and additionally identified a channelized topographic feature to the northwest of Wet1 on the perimeter of a hay field. The depression appeared to receive precipitation runoff from the elevated areas of the hay field. No connection could be identified from Wet 1 to the topographic channel or from the channel to the intermittent hydrologic feature identified on the 1977 topo map northwest of Boudreaux Road. Wet 1 is therefore considered an isolated water. Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies.

In conclusion: Wet 1 is not currently used, wasn't used in the past, nor is it susceptible to use in interstate or foreign commerce. It is not subject to the ebb and flow of the daily tide, nor is it part of a territorial sea. It does not cross interstate or tribal boundaries. Wet 1 does not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. This wetland is not an impoundment of waters of the United States. Wet 1 is not nor ever was part of a surface tributary system of previous waters. This wetland is not adjacent to any other waters previously identified. Wet 1 has been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). It is located out of any 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States. Wet 1 in the Corps draft determination is an isolated wetland (as per federal regulation) that does not possess any known nexus to interstate commerce and as such is not subject to federal regulation under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland conditions formed within a Wockley-Gessner Loam soil formation, outside of the 100 year floodplain. The area is surrounded on all sides by uplands. The principal hydrology is precipitation and has no direct surface hydrologic connection to any water of the U.S. The

closest identified intermittent feature to the wetland that is mapped on the 1977 topo is in a higher landscape position than the wetland. This mapped feature is approximately 1,202 feet away from the nearest edge of this wetland. There is also a road and an upland hay field separating the wetland from the intermittent feature. Wet 1 is located approximately 4,600 feet from Willow Creek, the nearest confirmed Water of the United States.

Wetland (Wet 1) has been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plains Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which require that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support this aquatic ecosystem. This 2.3 acre wetland (Wet 1) is located in a depressional landscape position, with an underlying hydric soil (mapped as Wockley Fine Sandy Loam). The primary source of hydrology is precipitation. The 1916 USGS topographic map does not indicate any waters at this location or in the immediate vicinity of this location. The 1977 topo also does not indicate any waters at this location, but does indicate a mapped intermittent hydrologic feature located to the northwest of the project area, approximately 1,202 feet away from the nearest edge of this wetland on the northwest side of Boudreaux Road. There is no confined surface hydrologic connection between the wetland and the intermittent feature. The wetland is above the 100 year FEMA floodplain as reflected on the Flood Insurance Map; it is mapped as Zone "X". The NWI map indicates the wetland as PEM1A; indicating the source of hydrology is Palustrine (ponded). Infrared aerial photos were reviewed and indicate that this wetland is located in a receiving (lower) landscape position and it is surrounded by uplands; the uplands are located higher in elevation. The 28 July 2012, site visit confirmed the offsite data and additionally identified a channelized topographic feature to the northwest of Wet1 on the perimeter of a hay field. The depression appeared to receive precipitation runoff from the elevated areas of the hay field. No connection could be identified from Wet 1 to the topographic channel or from the channel to the intermittent hydrologic feature identified on the 1977 topo map northwest of Boudreaux Road. Wet 1 is therefore considered an isolated water. Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies.

In conclusion: Wet 1 is not currently used, wasn't used in the past, nor is it susceptible to use in interstate or foreign commerce. It is not subject to the ebb and flow of the daily tide, nor is it part of a territorial sea. It does not cross interstate or tribal boundaries. Wet 1 does not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. This wetland is not an impoundment of waters of the United States. Wet 1 is not nor ever was part of a surface tributary system of previous waters. This wetland is not adjacent to any other waters previously identified. Wet 1 has been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). It is located out of any 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States. Wet 1 in the Corps draft determination is an isolated wetland (as per federal regulation) that does not possess any known nexus to interstate commerce and as such is not subject to federal regulation under Section 404 of the Clean Water Act.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Wetland conditions formed within a Wockley-Gessner Loam soil formation (a Gessner Pond), outside of the 100 year floodplain. The area is surrounded on all sides by uplands. The principal source of hydrology is precipitation and has no direct surface hydrologic connection to any

water of the U.S. The closest identified intermittent feature to the wetland that is mapped on the 1977 topo is in a higher landscape position than the wetland. This mapped feature is approximately 913 feet away from the nearest edge of this wetland. There is also a road and an upland hay field separating the wetland from the intermittent feature. Wet 2 is located approximately 4,100 feet from Willow Creek, the nearest confirmed water of the United States.

Wetland (Wet 2) has been identified in accordance with requirements set forth in the Atlantic and Gulf Coastal Plains Regional Supplement to the 1987 Corps of Engineers Wetland Delineation Manual; which require that, under normal circumstances, an area has predominantly hydrophytic vegetation, hydric soils, and sufficient hydrology to support this aquatic ecosystem. This circular approximately 2.9 acre wetland (Wet 2) is located in a depressional landscape position with an underlying mapped hydric soil (Gessner Loam). The primary source of hydrology is precipitation. The 1916 USGS topographic map indicates a water at this location with no hydrologic connections in the vicinity. The 1977 topo also indicates a water at this Gessner Pond location, with no hydrologic features connected to it. The newer topo indicates a mapped intermittent hydrologic feature located to the northwest of the project area, approximately 913 feet away from the nearest edge of this wetland on the northwest side of Boudreaux Road. There is no confined surface hydrologic connection between the wetland and the intermittent feature. The wetland is above the 100 year FEMA floodplain as reflected on the Flood Insurance Map; it is mapped as Zone "X". The NWI map indicates the wetland as PSS1F; indicating the source of hydrology is Palustrine (ponded). Infrared aerial photos were reviewed and indicate that this wetland is located in a receiving (lower) landscape position and it is surrounded by uplands; the uplands are located higher in elevation. The 28 July 2012, site visit supported the offsite data and confirmed what appeared in some historic aerial images to have been a hydrologic feature flowing from the wetland was actually a non-wetland swale that drains precipitation from the adjacent elevated hay field to Wet 2. No other possible connection could be identified from Wet 2 to the intermittent hydrologic feature identified on the 1977 topo map northwest of Boudreaux Road. Wet 2 is therefore considered an isolated water. Isolated waters are defined in federal Regulations 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable water of the United States; and (2) Not adjacent to such tributary water bodies.

In conclusion: Wet 2 is not currently used, wasn't used in the past, nor is it susceptible to use in interstate or foreign commerce. It is not subject to the ebb and flow of the daily tide, nor is it part of a territorial sea. It does not cross interstate or tribal boundaries. Wet 2 does not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. This wetland is not an impoundment of waters of the United States. Wet 2 is not nor ever was part of a surface tributary system of previous waters. This wetland is not adjacent to any other waters previously identified. Wet 2 has been determined by the Galveston District to be isolated (as defined in federal regulation 33CFR 330.2(e)). It is located out of any 100-year floodplain of any water of the United States and does not have a confined hydrological surface connection to any water of the United States. Wet 2 in the Corps draft determination is an isolated wetland (as per federal regulation) that does not possess any known nexus to interstate commerce and as such is not subject to federal regulation under Section 404 of the Clean Water Act.
