C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

C. SIGNIFICANT NEXUS DETERMINATION

- According to the TPWD website for Lake Corpus Christi State Park, there are at least eight boat ramps located within the 94-foot contour of Lake Corpus Christi and available to the public, several of which require a fee for use. These boat ramps are utilized for access to Nueces River and its tributaries.
- Guided fishing trips operate in the Lake Corpus Christi (also referred to as Lake Mathis by some locals) area, including the section of the Nueces River north of Lake Corpus Christi. The area referred to as “the lake” by locals, encompasses not only Lake Corpus Christi, but also Nueces River and its tributaries, up to the 94-foot contour line, the regulated pool elevation by the City of Corpus Christi. These fishing trips attract visitors from both in- and out-of-state, which supports commerce in this area.
- Several fishing tournaments, including Lone Star Lunkers, C.A.S.T., Live Wire, etc., are also held on Lake Corpus Christi, which has been noted for its largemouth bass, catfish, crappie, white bass, and sunfish. These tournaments are attended by both in and out of state anglers and require an entrance fee and that the fish be caught within the Lake Corpus Christi boundaries, which encompass the 94-foot conservation pool elevation.
- There are numerous lodging facilities located along Lake Corpus Christi, which offer canoe and/or kayak rentals to their guests, including KOA Kampgrounds, Boy Scouts' Camp Karankawa , Girl Scouts' Camp Greenhill, etc.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
