C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.



Explain: There are two wetlands on Tract 1 of the project site. The nearest water of the United States is an unnamed tributary to the Sabine River. The unnamed tributary is a relatively permanent water. The nearest Traditional Navigable Water is the Sabine River, which is located approximately 1.85 aerial miles east of the tract. Wetland WA is forested wetland. Wetland

WA is a closed depression that is located approximately 2,050 feet north of the unnamed tributary to the Sabine River and approximately 2 miles west of the Sabine River. Wetland WB is a forested wetland and a closed depression located approximately 1,500 feet north of the unnamed tributary to the Sabine River and approximately 1.83 miles west of the Sabine River. There are no known hydrological connections between Wetlands WA or WB and the unnamed tributary to the Sabine River. There are no confined hydrologic connections between Wetlands WA or WB and any water of the United States. Wetlands WA and WB are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Wetlands WA and WB are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. Wetlands WA and WB are not subject to the ebb and flow of the daily tide. Wetlands WA and WB do not cross interstate or tribal boundaries. The destruction of Wetlands WA or WB (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. Wetlands WA and WB are not an impoundment of a water of the United States. Wetlands WA and WB are not part of a surface tributary system of any of the above. Wetlands WA and WB are not part of the territorial seas. Wetlands WA and WB are not adjacent to waters identified in any of the above. Wetlands WA and WB have been determined by the Galveston District to NOT be adjacent, (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c). Wetlands WA and WB are located out of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States. Wetlands WA and WB are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. Wetlands WA and WB have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators and hydric soils.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: There are two wetlands on Tract 1 of the project site. The nearest water of the United States is an unnamed tributary to the Sabine River. The unnamed tributary is a relatively permanent water. The nearest Traditional Navigable Water is the Sabine River, which is located approximately 1.85 aerial miles east of the tract. Wetland WA is forested wetland. Wetland WA is a closed depression that is located approximately 2,050 feet north of the unnamed tributary to the Sabine River and

approximately 2 miles west of the Sabine River. Wetland WB is a forested wetland and a closed depression located approximately 1,500 feet north of the unnamed tributary to the Sabine River and approximately 1.83 miles west of the Sabine River. There are no known hydrological connections between Wetlands WA or WB and the unnamed tributary to the Sabine River. There are no confined hydrologic connections between Wetlands WA or WB and any water of the United States. Wetlands WA and WB are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Wetlands WA and WB are not currently used, or were used in the past, nor are susceptible to use for interstate or foreign commerce. Wetlands WA and WB are not subject to the ebb and flow of the daily tide. Wetlands WA and WB do not cross interstate or tribal boundaries. The destruction of Wetlands WA or WB (intrastate wetlands) would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce. Wetlands WA and WB are not an impoundment of a water of the United States. Wetlands WA and WB are not part of a surface tributary system of any of the above. Wetlands WA and WB are not part of the territorial seas. Wetlands WA and WB are not adjacent to waters identified in any of the above. Wetlands WA and WB have been determined by the Galveston District to NOT be adjacent, (bordering, contiguous, or neighboring) as defined by 33CFR 328.3(c). Wetlands WA and WB are located out of the 100-year floodplain of any water of the United States and do not have a confined hydrological surface connection to any water of the United States. Wetlands WA and WB are isolated wetlands as defined in 33 CFR 330.2(e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States, and are not adjacent to such tributary waterbodies. Wetlands WA and WB have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators and hydric soils..


