- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: This feature is the extreme upper reaches of an old agriculture ditch near the Colorado River . It is appx 1,700 linear feet long and mean average width of appx 2' wide. During the December 2015 site visit we did not witness any water flowing. This ditch/feature historically had a water control gate on the north end used to pump water into and flood the fields from an elevated irrigation canal. The southern end of this section has an elevated road crossing with an elevated culvert that is used to

flood the field during cropping and still afford them the ability to not flood out the crop by creating a high water overflow to release water to the headwaters. The culvert (High water over flow) is located 4-5' above grade to prevent from excessive flooding of the field. The Colorado River is located greater than 4,700' from this intersection with the feature in review (ditch) and the ephemeral tributary that flows to the Colorado River

The water in this ditch/feature is palustrine and lentic and has pockets of water after rain events and seasonal at best; the only flow is in rain events and extreme storm events.

This feature is located above the 100 year flood plain elevation. It is not found on USGS maps. It is surround by uplands. The USGS maps indicate there is a depression in this location, but there is not an identified waterway.

There were not any know biological species found in this aquatic feature that would require the TNW and this feature to fulfill life cycle requirements.

There are not any known identified chemical attributes that this reach provides that are more than speculative or insubstantial upon the chemical integrity of the downstream TNW (e.g. nothing is identified as an impaired water).

The slowing of the waters into the TNW (which only occurs after rain events) is the only known potential physical attribute that this feature might provide. As such, it is SWG draft determination that this feature does not provide more than a speculative or insubstantial effect upon the physical integrity of the downstream TNW.

Therefore, it SWG draft deteremination that this appx 1,700 reach of this aquatic feature/agriculture ditch does not have a more than a speculative or insubstantial effect on the chemical, physical, and/or biological integrity of the downstream TNW (Colorado River) and as such is not a water of the United States subject to Section 404 of the Clena Water Act. .

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This waters in this ditch/feature are lentic at best and do not flow except in extreme storm events.

There were not any know biological species found in this aquatic feature that would require the TNW and this feature to fulfill life cycle requirements. There are not any known identified chemical attributes that this reach provides that are more than speculative or insubstantial upon the chemical integrity of the downstream TNW (none of these aquatic features are identified as an impaired water). The pond of the waters into the TNW (which only occurs after extreme flood events) is the only possible physical attribute that this feature could speculatively provided.

Therefore, it is SWG draft determination that this feature/ditch does not provide more than a speculative or insubstantial effect upon the chemical, physical and/or biological integrity to the downstream TNW.

This was excavated thru a farm field and the ditch/feature historically had a water control gate on the north end used to flood the field from the elevated irrigation canal that is north of the site. The southern end of the ditch has an elevated culvert is located 4-5' above grade and it can allow flow to the tributary it connects to during storm events. The Colorado River is located appx 3,700' from this intersection with the feature in review (ditch) and the ephemeral tributary.

This waters in this ditch/feature are lentic at best and do not flow except in extreme storm events.

There were not any know biological species found in this aquatic feature that would require the TNW and this feature to fulfill life cycle requirements. There are not any known identified chemical attributes that this reach provides that are more than speculative or insubstantial upon the chemical integrity of the downstream TNW (none of these aquatic features are identified as an impaired water). The pond of the waters into the TNW (which only occurs after extreme flood events) is the only possible physical attribute that this feature could speculatively provided.

Therefore, it is SWG draft determination that this feature/ditch does not provide more than a speculative or insubstantial effect upon the chemical, physical and/or biological integrity to the downstream TNW.
