- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Features 1E, 4E, 5E, 6E, 8E, 9E, 11E, 13E, 14E, 15E, and 18E are all emergent wetlands that formed in areas scraped for industrial fill material, the creation of roads, or maintenance of berms. According to historic aerials (1950, 1961), the project review area was historically used as an agricultural field and industrial storage area. Most of the wetlands were

invaded by King Ranch bluestem, western ragweed, spikerush (*Eleocharis* sp., FACW-OBL) and cattail. The combination of non-hydrophytic vegetation with obligates is indicative of disturbed areas; therefore, these emergent areas likely support wetland plants due to the heavy rainfall experienced in early summer 2015 and are not considered jurisdictional wetlands. Historical aerial photography (1950) shows the previous landscape to be comprised of undeveloped coastal prairie. No previous wetland, lake, or drainage features were located where these isolated wetlands developed. The wetlands are non-regulated water-filled depressions created in dry land incidental to construction activity; therefore, they are non-jurisdictional.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

No previous wetland, lake, or drainage features were located where these isolated wetlands developed. All of these features are isolated emergent wetlands that have no surface connection to a jurisdictional stream or wetland. It appears from historical aerial photography that water is only present within these features during heavy rainfall events and evaporates. No other potential areas for flow in or out of the wetlands were found during the delineation. The area was likely scraped for industrial use and holds water after rainfall but does not convey water to any other surrounding features. The wetlands are non-regulated water-filled depressions created in dry land incidental to construction activity; therefore, they are non-jurisdictional.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Features 1E, 4E, 5E, 6E, 8E, 9E, 11E, 13E, 14E, 15E, and 18E are all emergent wetlands that formed in areas scraped for industrial fill material, the creation of roads, or maintenance of berms. According to historic aerials (1950, 1961), the project review area was historically used as an agricultural field and industrial storage area. Most of the wetlands were invaded by King Ranch bluestem, western ragweed, spikerush (*Eleocharis* sp., FACW-OBL) and cattail. The combination of non-hydrophytic vegetation with obligates is indicative of disturbed areas; therefore, these emergent areas likely support wetland plants due to the heavy rainfall experienced in early summer 2015 and are not considered jurisdictional wetlands. Historical aerial photography (1950) shows the previous landscape to be comprised of undeveloped coastal prairie. No previous wetland, lake, or drainage features were located where these isolated wetlands developed. All of these features are isolated emergent wetlands that have no surface connection to a jurisdictional stream or wetland. It appears from historical aerial photography that water is only present within these features during heavy rainfall events and evaporates. No other potential areas for flow in or out of the wetlands were found during the delineation. The area was likely scraped for industrial use and holds water after rainfall but does not convey water to any other surrounding features. The wetlands are non-regulated water-filled depressions created in dry land incidental to construction activity; therefore, they are non-jurisdictional.



Historical aerial photography (1950, 1961) show the previous landscape to be comprised of undeveloped coastal prairie. No previous wetland, lake, or drainage features were located where these ponds were constructed. Historical aerial photography (1950, 1961) indicates the area was cleared and the topsoil scraped. Removal of material from Feature 16E appears to have begun around 2003 and the area continues to be manipulated for industrial purposes. There were no hydrological indicators, hydrologic vegetation, or hydric soil indicators identified. 

review area along a dirt road and drains into Feature 3E. Feature 10E is south of, and runs parallel to, Feature 7E and drains into Feature 3E. Feature 12E is a short ditch that flows north into Feature 10E. Dominant plant species along these features includes King Ranch bluestem (*Bothriochloa ischaemum*, NI), curly dock (*Rumex crispus*, FAC), western ragweed (*Ambrosia psilostachya*, FAC), bristle grass (*Setaria parviflora*, FACW) and Johnsongrass (*Sorghum halepense*, FACU). These ditches are heavily vegetated on both the banks and bed, and lack an OHWM. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. 

For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.





C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). 


