Ms. Anslow serves as Chief of the Planning and Policy Division for the Southwestern Division. In this position she is responsible for oversight of all analysis and documentation for the Divisions' water resources planning program, including preparation of feasibility studies, water supply storage reallocation studies, environmental documents, Continuing Authority Programs (CAP) decision documents, master planning, and flood hazard studies. These documents are normally used for the basis of federal investment decisions and congressional authorization for construction projects. She works collaboratively with the four Districts in the Division, stakeholders, federal, and state partners in Arkansas, Missouri, Oklahoma, and Texas to determine environmentally sustainable engineering water resource solutions that lead to economic development opportunities for the region and nation. She concurrently serving as the Director of the USACE Planning Center of Expertise for Water Management and Reallocation Studies. The Planning Center of Expertise supports review and execution of Water Supply decisions and the development of policy throughout the US Army Corps of Engineers. Prior to this assignment, Ms. Anslow served for 10 years as the Chief of Planning & Environmental Division at the Little Rock District.



Ms. Anslow began her career with the Corps in 1994. Her initial assignment was as the District's Geographic Information Systems (GIS) Manager. After five years in that position she went on to serve as a study manager and project manager in the Planning Branch, Planning Division. In 2002, she was named Chief of the Environmental Section of Planning, Environmental and Regulatory Division until her selection as Chief of the Planning and Environmental Division. Prior to joining the Little Rock District Corps of Engineers, Ms. Anslow was commissioned as a Second Lieutenant in the U.S. Army Corps of Engineers. In 1993 she transitioned to the Army National Guard. She is traditional part-time Soldier assigned with the U.S. Forces Korea.

Ms. Anslow earned a Bachelor of Science Degree in Geography from the United States Military Academy, West Point, New York in 1989. She also holds Bachelor of Science Degree in Biology from the University of Arkansas at Little Rock, a Masters of Science Degree in Water Resource Planning from Johns Hopkins University, and Masters of Science in Strategic Studies from the U.S. Army War College. She is a member of the Society of American Military Engineers and a lifetime member of the Engineer Regiment.

During her career with the Corps, she has received numerous performance awards including the USACE Team Planning Achievement Award (2012), Commander's Award for Civilian Service (2003, 2010), the Achievement Medal for Civilian Service (1999), the Federal Employee of the Year (1997), and the Little Rock District Planning Excellence Award (1996).
