- ➤ Coastal Storm Risk Management Mission



Federal Acquisition Regulation (FAR) Overhaul

Under <u>Executive Order 14275</u>, Restoring Common Sense to Federal Procurement, the federal government is undertaking the most significant update to its procurement rules in more than 40 years.

Further insight into the initiative and development of a new Strategic Acquisition Guidance framework is available in the related OMB memorandum M-25-26.

This revolutionary effort will:

- remove non-statutory requirements
- •rewrite the FAR in plain language
- •create a faster, more agile, and mission-focused acquisition system.

The goal is to empower our acquisition workforce to deliver capabilities faster, with greater value and better results for our military and nation.






