The Trinity River Authority of Texas is an innovative, adaptive leader, enriching the Trinity basin as a resource for Texans.




LINKED TO THE COMMUNITY

TRA provides water and wastewater treatment, along with recreation and reservoir facilities for cities within the nearly 18,000-square-mile Trinity River basin.


PROVIDING ESSENTIAL SERVICES

Largest wholesale provider of wastewater treatment services in Texas. Specializes in development and operation of multiparticipant regional facilities.




TRA'S POLITICAL JURISDICTION

TRA's 25-member board is the largest such body in the state


Four board members from Dallas County

PURPOSE OF VISION PLAN

Trinity River Authority (TRA) has engaged the US Army Corps of Engineers (USACE) Galveston District (SWG) through the Planning Assistance to States program to develop a Port Vision Plan.

The purpose of the project is to develop a Vision Plan that projects future growth and commerce for a potential Port in Liberty, TX taking into consideration the environmental, economic, and social aspects of the site and community.

The Vision Plan will address future land use and strategic development, analyze and identify best and highest uses for current Port facilities including terminals, and industrial properties, and will prioritize development and expansion for 5, 10, and 20-year planning horizons.

The Vision Plan is a living document designed to be adaptable and periodically reviewed, incorporating new information and developments, refining market projections and opportunities, and evaluating and updating development and investment priorities.

- Background of Port History, Demographics, Environmental, and Economic Development
- Development of planning vision, goals and objectives
- Environmental Constraints and Opportunities
- Development of Land Use and Development Alternatives

Vision Plan Contents

- Market Analysis
- Facilities Evaluation and Capacity
- Rail, Highway, and Inland Waterway Access Evaluation
- Alternative Cargo Demand Scenarios
- Capital Program Development (5, 10, 20 Year Projects)
