**2026 DRAFT ADDICKS AND BARKER
MASTER PLAN AND ENVIRONMENTAL ASSESSMENT
ADDICKS AND BARKER RESERVOIR, SAN JACINTO RIVER BASIN
HARRIS AND FORT BEND COUNTIES, TEXAS**

The U.S. Army Corps of Engineers (USACE), Regional Planning and Environmental Center (RPEC), hereby informs the public that the 2026 Draft Addicks and Barker Master Plan (MP), Finding of No Significant Impact (FONSI), and Environmental Assessment (EA) are available for public review. An open house will be held from **4:00 PM to 6:00 PM on January 21st, 2026, at The Glazier Community Center, 16600 Pine Forest Ln, Houston, TX 77084**.

The public open house will give an overview of the proposed changes to the current Addicks and Barker MP, provide instructions on how to submit comments, and provide an opportunity for the public to ask questions and provide feedback. The 30-day public comment period will begin on January 21st, 2026, and end on February 20th, 2026. For those unable to attend the public open house, the draft MP, EA, FONSI, comment form with instructions, and a downloadable presentation covering the same topics covered in the open house will be available for download starting on January 21st, 2026, at the following USACE Galveston District website:

The MP is a vital tool produced and used by the USACE to guide the responsible stewardship of the USACE administered lands and resources for present and future generations. The MP provides direction for appropriate management, use, development, enhancement, protection, and conservation of the natural, cultural, and manmade resources at the Addicks and Barker Reservoirs. The MP presents an inventory and analysis of land resources, resource management objectives, land use classifications, a resource use plan for each land use classification, current and projected park facility needs, an analysis of existing and anticipated resource use, and anticipated influences on overall project operation and management. The most recent MP for Addicks and Barker was last approved in 2009. Key topics to be addressed in the revised MP include revised land use classifications, new natural and recreational resource management objectives, recreation facility needs, and special topics such as invasive species management and threatened and endangered species habitat. **Public participation is critical to the successful revision of the 2009 Master Plan.**
