Explain: **This AJD is for a Fort Bend County linear project of approximately 2.7 miles for the proposed Lake Olympia Parkway road extension located between Farm-to-Market Road (FM) 521 to Chimney Rock Road, in Fort Bend**

County, Texas. Based on a review of available information, we have determined that the approximate 2.7-mile road extension contains nine wetlands (see attached table) totaling approximately 4.87-acre, and 3 ditches (Ditches 1, 3 and 4) totaling 557 linear feet. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement to the 1987 Corps of Engineers Wetland Delineation Manual. They are depressional wetlands with precipitation as the primary source of hydrology. The nearest known water of the United States (a relatively permanent water {RPW}) for Wetland 1, 2, 4, 5, 6, 7, 8, 9 and 10 is Mustand Bayou. See attached table for approximate distances of each wetland to nearest RPW. The nearest traditional navigable waterways (TNW) is Lower Mustang Bayou and Chocolate Bay. Mustang Bayou becomes a TNW approximately 25 aerial miles southeast from Wetlands 1, 2, 4, 5, 6, 7, 8, 9 and 10. Chocolate Bay is approximately 7.5 aerial miles away from the portion of Mustang Bayou that is considered a TNW. Chocolate Bay is approximately 32.5 aerial miles from Wetlands 1, 2, 4, 5, 6, 7, 8, 9 and 10. Based on our review, none of these aquatic features have surface hydrologic connection to any waters of the U.S.

The wetlands are not subject to the ebb and flow of the daily tide, are not currently used, were used in the past, nor are susceptible to use for interstate or foreign commerce.

The wetlands do not cross interstate or tribal boundaries.

The destruction of the intrastate wetlands would not affect interstate or foreign travelers for recreational or other purposes, would not affect fish or shellfish that could be taken and sold in interstate or foreign commerce, and would not affect the current use or potential use for industrial purposes by industries in interstate commerce.

The wetlands are not impoundments of a water of the United States.

The wetlands are not tributaries nor are they part of a tributary system.

The wetlands are not part of the territorial seas.

The wetlands are not "adjacent" (per Federal Regulations 33 CFR 328 (b) defines "adjacent" as bordering, neighboring, or contiguous to a water of the US).

The wetlands are not part of a prior converted cropland.

The wetlands have been determined to be "isolated" per Federal Regulations. (33 CFR 330.2 (e): those non-tidal waters of the United States that are not part of a surface tributary system to interstate or navigable waters of the United States nor adjacent to such tributary waterbodies). Based on the site review and floodplain maps, it was determined that the wetlands are located above the anticipated high flow of any waterway (e.g., outside of the 100-year floodplain) and the wetlands have no nexus to interstate commerce associated with it. There are no known species in this georegion that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements. As such they are not "ecologically adjacent", as defined in the Rapanos as being "reasonably close" such that an ecologic interconnectivity is beyond speculation and insubstantial. The wetlands have no known nexus to interstate commerce and are not waters of the United States subject to Section 404 of the Clean Water Act (Section 404) or Section 10 of the Rivers and Harbors Act (Section 10).

Also, the three ditches were excavated from uplands or non-jurisdictional waters, do not drain wetlands into waters of the U.S., are not re-routed tributaries and do not extend the ordinary high water mark of a water of the U.S. Therefore, the ditches are not waters of the U.S. and are not subject to Section 404 or Section 10.

The American Canal is part of the property tract. An area of the American Canal approximately 210 feet wide will be spanned by a bridge. The American Canal is a man-made drainage feature that was constructed out of uplands and is considered uplands by the Corps. It is visible in aerial imagery starting in 1984.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
