- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **Off-site and on-site review of Site-1 and Site-2 reveals that these features were created wholly within the uplands and the Corps determined that Site-1 and Site 2 appear to have been excavated from dry land as a stock pond and a drainage ditch and are not jurisdictional waters of the US. Site-1 (1056 linear feet) appears to be a runoff/ rain driven drainage feature. Site-2 (0.25-acre) consists of a stock pond with no observable wetland vegetation within or along the edges of Site-2. Per the preamble for 33 CFR 328.3 (b), Stormwater control features constructed or excavated in upland or in non-jurisdictional waters to convey, treat, infiltrate, or store stormwater run-off are not considered waters of the US and do not require a permit under Section 404 of the Clean Water Act. Also, per the preamble for 33 CFR 328.3 (b)(8) Artificial lakes and ponds, including water storage reservoirs and farm, irrigation, stock watering, and log cleaning ponds, constructed or excavated in upland or in non-jurisdictional waters, so long as those artificial lakes and ponds are not impoundments of jurisdictional waters are not considered waters of the U.S.. Therefore, we determined that Site-1 and Site-2 does not require a Section 404 permit of the Clean Water Act..**

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Off-site and on-site review of Site-1 and Site-2 reveal that these features were created wholly within the uplands and the Corps determined that Site-1 and Site 2 appear to have been excavated from dry land as a stock pond and a drainage ditch and are not jurisdictional waters of the US. Site-2 (1056 linear feet) appears to be a runoff/ rain driven drainage ditch. Site-1 (0.25-acre) consists of a stock pond with no observable wetland vegetation within or along the edges of Site-2. Per the preamble for 33 CFR 328.3 (b), Stormwater control features constructed or excavated in upland or in non-jurisdictional waters to convey, treat, infiltrate, or store stormwater run-off are not considered waters of the US and do not require a permit under Section 404 of the Clean Water Act. Also, per the preamble for 33 CFR 328.3 (b)(8) Artificial lakes and ponds, including water storage reservoirs and farm, irrigation, stock watering, and log cleaning ponds, constructed or excavated in upland or in non-jurisdictional waters so long as those artificial lakes and ponds are not impoundments of jurisdictional waters, are not considered waters of the U.S. Therefore, we determined that Site-1 and Site-2 do not require a DA permit under Section 404 of the Clean Water Act.
