There are two non-jurisdictional ditches (Ditch A (U106-13-00) and Ditch B (U106-08-00)), and one non-jurisdictional swale (Swale A) within the project site.

Ditch A and Ditch B are concrete lined features that were constructed within uplands that drains surface water runoff from surrounding property into Stream A (Horsepen Creek). Both Ditch A and Ditch B do not extend the OHWM of Horsepen Creek. At the time of the site visit, Ditch A and Ditch B were carrying water, and there was no hydrophytic vegetation within the OHWM of either ditch (concrete lined). There is no surface hydrologic connection between Ditch A or Ditch B and other features within the project site, and they do not drain wetlands. These ditches are not jurisdictional pursuant to Section 404 of the CWA.

Swale A appears to have formed as a result of surface water runoff flowing parallel to Horsepen Creek along a topographical depression that eventually drains to Ditch A. At the time of the site visit, Swale A was not holding or conveying water, there was no hydrophytic vegetation within or around its OHWM, and there was no established bed or bank. There is no surface hydrologic connection between Swale A and other on-site aquatic features, and it does not drain wetlands. This swale A is not jurisdictional pursuant to Section 404 of the CWA.

“Waters of the U.S.” are defined in 33 CFR 328.3 (a) 1 thru 7 which is addressed in the following. Due to the fact that these : (1) are not currently used, or were used in the past, nor susceptible to use for interstate or foreign commerce nor subject to the ebb and flow of the daily tide; (2) do not cross interstate or tribal boundaries; (3) the destruction of these wetlands is not expected to affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or (iii) current use or potential use for industrial purposes by industries in interstate commerce; (4) are not impoundments of Waters of the U.S.; (5) are not part of a surface tributary system of (a) (1) through (4); (6) are not part of the territorial seas; and (7) are not adjacent to Waters of the U.S. identified in (a) (1) through (6). Therefore, Ditch A, Ditch B and Swale A lack a nexus to interstate commerce and are not Waters of the U.S. subject to Section 404 of the Clean Water Act.

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW.

Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
