**Dickinson Bayou Bypass Channel runs through the site. This feature is higher in elevation than Dickinson Bayou and does not reroute Dickinson Bayou. Its channel is above the OHWM of Dickinson Bayou. It is a non-tidal, upland man made ditch. Also, a large irrigation ditch enters the property from the north and flows into the Dickinson Bayou Bypass Channel. This irrigation ditch is not a re-route and does not extend the OHWM of a water of the United States and therefore is not a water of the United States. Two stormwater management ponds were built on the property as part of the project plans after the 2018 AJD was issued. The ponds do not meet the definition of the waters of the United States based on the 1986 regulations and Rapanos Guidance. Therefore, the ponds are not subject to Section 404 of the Clean Water Act or Section 10 of the Rivers and Harbors Act..**

Dickinson Bayou is identified by the Galveston District as a traditional navigable water (TNW) as listed on the 2 September 1971 U.S. Army Corps of Engineers Navigable Waters List and Dickinson Bayou is navigable 20 miles in length from its confluence. Therefore, Dickinson Bayou is a water of the United States subject to Section 10 of the Rivers and Harbors Act of 1899 and Section 404 of the Clean Water Act. .

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** 4. Dickinson Bayou is identified by the Galveston District as a traditional navigable water (TNW) as listed on the 2 September 1971 U.S. Army Corps of Engineers Navigable Waters List and Dickinson Bayou is navigable 20 miles in length from its confluence. Therefore, Dickinson Bayou is a water of the United States subject to Section 10 of the Rivers and

Harbors Act of 1899 and Section 404 of the Clean Water Act. The remaining wetland identified on the property in the 2018 AJD is Wetland D, totaling approximately 4 acres. This wetland is neighboring and is within the 100-year flood plain of Dickinson Bayou, making it adjacent to Dickinson Bayou, a TNW. Therefore, Wetland D is subject to Section 404 of the Clean Water Act and any discharge of dredged and/or fill material into Wetland D would require a Department of the Army permit. .
