Summarize rationale supporting determination: The Brownsville Ship Channel is listed on Galveston District's Navigable Waters list (Section 10 list). The Brownsville Ship Channel has been, is currently used, and has potential to be used in the forseeable future for interstate commerce. All Section 10 waters are Traditionally Navigable Waters and are subject to jurisdiction under Section 404 of the Clean Water Act.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is "adjacent": The two listed wetlands are within the flood plain of the Brownsville Ship Channel, listed as a Traditionally Navigable Water under Section 10 of the Rivers and Harbors Act. The two wetlands with measured acreage limited by the applicant's project boundaries are portions of a much larger wetland complex, with the immediate contiguous palustrine wetland coverage determined by the National Wetlands Inventory as 206.62 and 63.51 acres, respectively. From the project location, the wetlands drain generally to the northwest toward a tidally influenced drainage ditch directly connected to the Brownsville Ship Channel, through a plain consisting largely of wetlands interspersed with slightly higher ground inhabited with sporadic honey mesquite and prickly pear cactus growing amongst meadows consisting predominantly of sea ox-eye daisy. The wetlands associated with the aforementioned flood plain have more than a speculatative or insubstantial effect on the chemical, physical, and/or biological integrity of the Brownsville Ship Channel.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Summarize overall biological, chemical and physical functions being performed: The two listed wetlands are within the flood plain of the Brownsville Ship Channel, which is listed as Traditionally Navigable Waters under Section 10 of the Rivers and Harbors Act. The two wetlands with measured acreage limited by the applicant's project boundaries are portions of a much larger wetland complex, with the immediate contiguous palustrine wetland coverage determined by the National Wetlands Inventory as 206.62 and 63.51 acres, respectively. Chemically, the wetlands provide a system for the breakdown and settling of non-point source pollutants. Biologically, the wetlands provide habitat and water for numerous avian and terrestrial faunal species, as well as region-specific hydric plant growth in an otherwise prairie-dominated area. Physically, the wetlands provide floodwater storage for occasionally heavy rains and storm surge to pool up and flow through the Brownsville Ship Channel in a more sustained rate. The wetlands associated with the aforementioned flood plain has more than a speculatative or insubstantial effect on the chemical, physical, and/or biological integrity of the Brownsville Ship Channel.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
