### **SECTION III: CWA ANALYSIS**

#### **A. TNWs AND WETLANDS ADJACENT TO TNWs**

The agencies will assert jurisdiction over TNWs and wetlands adjacent to TNWs. Summarize rationale supporting determination: As defined in 33 CFR 328.3(a)(1), all waters which are subject to the ebb and flow of the tide are waters of the U.S. Furthermore, as defined in 33 CFR 328.4, the landward limit of CWA jurisdiction in tidal waters extends to the high tide line (HTL). Although the high tide line was not established for the purposes of this review, evidence documented during the desktop review and site visit confirm that the review area contains wetlands (WET1) and unvegetated mud flats (NONWET1) that experience the ebb and flow of the tide from the Laguna Madre. The Laguna Madre is subject to the ebb and flow of the tide; therefore, it is a TNW.

##### **2. Wetland adjacent to TNW**

Summarize rationale supporting conclusion that wetland is “adjacent”: As defined in 33 CFR 328.3(c), adjacent means those wetlands that are bordering, contiguous, or neighboring waters identified in paragraphs (a)(1) through (6) of 33 CFR 328.3. The two wetlands identified within the review area meet all three wetland criteria. Although the review area is separated from the Laguna Madre by Laguna Shores Road, according to the adjacency definition, wetlands separated from other waters of the U.S. by man-made barriers are adjacent wetlands. Although the high tide line boundary was not established for the purpose of this review, a wetland (WET2) identified within the review area is located within close proximity and in an appropriate geomorphic position in relation to the Laguna Madre to classify is as adjacent.

#### **B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):**

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Tidal influence within the review area is restricted by the presence of Laguna Shores Road, but is maintained by an existing culvert during annual high tide events

and during extreme weather events that cause waters from the Laguna Madre to flood over the road. Based on available information, while the annual high tide does extend into the review area, it appears that the mean high water line is restricted to the east side of Laguna Shores Road and does not extend into the review area. The wetlands and sand/mud flat documented within the review area occurs within and/or adjacent to the high tide line. Therefore, the aquatic resources identified within the review area are jurisdictional under Section 404 of the Clean Water Act, as defined in 33 CFR 328.3(a)(1) and (7).
