06-2562 NONWATER1 is an isolated seasonally inundated palustrine depressional wetland that is approximately 0.26 acre in size. It exhibits all three mandatory criteria to be determined a wetland. It is not tidal nor part of any intertidal system. It is not part of a surface water tributary or drainage system that shares a direct nexus to a downstream TNW.

It is not neighboring, bordering, or contiguous with a TNW or other water of the US. The main source of hydrology only comes when there is a high precipitation event; even so, the sandy soils do not retain the water for sufficiently long durations to make this resource a seasonal wetland. It is surrounded by natural bermed embankments on an elevated strandplain above the 100-year flood plain that separates it from having a surface connection with a downstream TNW or RPW. It is also surrounded by thick upland riparian brush consisting of live oak and green briar.

06-2562 NONWATER2 (0.46 acres): Latitude: 27.845417; Longitude: -97.187712

06-2562 NONWATER2 is a 0.46-acre depressional palustrine wetland that was excavated wholly from dry land. Its current state is incidental to the associated pipeline removal and borrow pit activities that occurred in uplands (14NOV2014 aerial). Three years after the pipelines and borrow pit activities were concluded, a manmade berm was erected on the western side of this wetland (to keep trespassers out) that created a ponding effect where 06-2562 NONWATER2 is located (17AUG2017 aerial). Due to the anthropogenic disturbances, it now exhibits the three mandatory criteria to be determined a wetland. Historical aerial photographs (between November 2014 and January 2017) indicate that this area shared the same vegetation coverage type with the adjacent uplands. The soils are highly disturbed and the organic matter has created a slightly restrictive layer in the soil matrix that slows water percolation through the Galveston Mustang Association sandy soils that typically drain quickly. This slow decomposing organic layer and low early successional growth of vegetation shows that these activities were done within recent years. If the area was restored and then left alone to naturalize, this area will restore to upland type characteristics.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

06-2562 NONWATER1 is an isolated seasonally inundated palustrine depressional wetland that is approximately 0.26 acre in size. It exhibits all three mandatory criteria to be determined a wetland. It is not tidal nor part of any intertidal system. It is not part of a surface water tributary or drainage system that shares a direct nexus to a downstream TNW. It is not neighboring, bordering, or contiguous with a TNW or other water of the US. The main source of hydrology only comes when there is a high precipitation event; even so, the sandy soils do not retain the water for sufficiently long durations to make this resource a seasonal wetland. It is surrounded by natural bermed embankments on an elevated strandplain above the 100-year flood plain that separates it from having a surface connection with a downstream TNW or RPW. It is also surrounded by thick upland riparian brush consisting of live oak and green briar.

06-2562 NONWATER2 is a 0.46-acre depressional palustrine wetland that was excavated wholly from dry land. Its current state is incidental to the associated pipeline removal and borrow pit activities that occurred in uplands (14NOV2014 aerial). Three years after the pipelines and borrow pit activities were concluded, a manmade berm was erected on the western side of this wetland (to keep trespassers out) that created a ponding effect where 06-2562 NONWATER2 is located (17AUG2017 aerial). Due to the anthropogenic disturbances, it now exhibits the three mandatory criteria to be determined a wetland. Historical aerial photographs (between November 2014 and January 2017) indicate that this area shared the same vegetation coverage type with the adjacent uplands. The soils are highly disturbed and the organic matter has created a slightly restrictive layer in the soil matrix that slows water percolation through the Galveston Mustang Association sandy soils that typically drain quickly. This slow decomposing organic layer and low early successional growth of vegetation shows that these activities were done within recent years. If the area was restored and then left alone to naturalize, this area will restore to upland type characteristics.

Therefore, based on current regulations and guidance these wetlands are not waters of the US defined in 33 CFR 328.3(a)(1)-(8); as such, it is our determination that these wetlands are not waters of the U.S. subject to jurisdiction under Section 404 of the Clean Water Act.
