SECTION III: CWA ANALYSIS

A. TNWs AND WETLANDS ADJACENT TO TNWs

Summarize rationale supporting determination: The shoreline of Packery Channel within the review area exhibits clear indications of the ebb and flow of the tide (i.e. abrupt vegetation changes, shoreline erosion, and deposit of debris). Packery Channel provides a direct hydrologic connection between the Laguna Madre and the Gulf of Mexico. As such, these waters within the review area are (a)(1) waters.

2. Wetland adjacent to TNW

Summarize rationale supporting conclusion that wetland is “adjacent”: A mangrove dominated estuarine emergent wetland and intertidal estuarine emergent wetland occur within the high tide line; therefore, these wetland features are included in the (a)(1) waters. One palustrine emergent wetland was delineated directly abutting the high tide line boundary; therefore, it is adjacent (bordering) to Packery Channel and the Laguna Madre. The six other palustrine emergent wetlands delineated within the review area are not directly abutting the high tide line, but are within 1,000 feet of the high tide line and within the 100-year floodplain of the Laguna Madre. Based on their landscape position and LiDAR elevations provided in the submitted delineation, these wetlands are depressional wetlands that provide rainwater runoff storage, sediment trapping, and retention of flood waters within the floodplain of the Laguna Madre. Due to their proximity to (a)(1) waters, these wetlands are adjacent (neighboring) wetlands.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
