C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The wetland delineation for the entire multi-phase mitigation bank was initially verified by the Corps on 11 March 2010. No work had begun on the Phase 8 (Field 6) cell by the date that the 2010 verification expired.

This JD request is therefore strictly focused on only the project area of the Phase 8 tract. The consultant submitted documents regarding the tract PCC status. The documents provided to support this claim included the officially filed FSA report of cropping history (9 years). They also submitted the USDA/NRCS Highly Erodeable Land and Wetland Conservation Determination with the attached delineation map signed by the NRCS inspector on 4 May 2010 (post-1995 mapping conventions). Review of these documents supports the position that NRCS determined a large area on site including Phase 8 (Field 6) to be a PCC field. Historical aerials and topographic maps were also reviewed. The oldest available aerial photo was from 1969. By that time, the entire mitigation area including Phase 8 was already surrounded by levees and ditches and was in agricultural service. However, the 1943 Sea Breeze, Texas Topo shows the area to not be in agricultural service yet. It also showed that in its pre-levee state, the historically mapped wetlands on site went almost half way up into the greater project area. At that time, there was also a tributary west of Phase 8 (Field 6) crossing diagonally, from north to south. This information further supports the NRCS determination that Phase 8 constitutes prior converted cropland. More recent aerials were then reviewed to determine if the area had remained in agricultural use since that time. All aerial images showed that the Phase 8 (Field 6) has been intermittently flooded and consistently farmed since the oldest aerial in 1969 to the most recent in 2017. This information supports the submitted cropping history representations and confirms that Phase 8 (Field 6) is a "Prior Converted Cropland." As such, any aquatic resources that may be on the site are exempt from Section 10 and Section 404 and would therefore be considered non-jurisdictional to the Corps of Engineers.
