This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

Based on our 9 January 2018 site visit and a review of on and off-site data associated with this request, we have determined that the project area contains waters of the United States, specifically a TNW and wetlands adjacent to a TNW.

The Gulf of Mexico is subject to interstate and foreign commerce as well as the ebb and flow of the daily tide and is a navigable water of the United States subject to Section 10 and Section 404. Based on a review of aerial imagery, Open Water A (totaling appx. 4.57 acres) is below the annual high tide line of the Gulf of Mexico and thus is a TNW.

The subject wetlands (Wets A - J) are within the anticipated high flow (100-year floodplain) and therefore neighbor the Gulf of Mexico. The 100-year floodplain is an area that experiences a 1% annual anticipated frequency of flooding, which contributes to water exchange. Since the Gulf of Mexico is a TNW, the wetlands are adjacent to a TNW.

Therefore, the wetlands within the project area and Open Water A are waters of the United States subject to Section 404 of the Clean Water Act, and any discharge of dredged and/or fill material into these jurisdictional waters would require a Department of the Army permit.
