using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils. The nearest water of the United States is Upper San Jacinto Bay, a traditional navigable water subject to the ebb and flow of the tide and is used to transport interstate commerce. Wetland1 is located approximately 1200 feet south of Upper San Jacinto Bay. Wetland2 is located approximately 1400 feet south of Upper San Jacinto Bay.

Based on the site visit conducted 10 February 2017, there are no known hydrological connection between the wetlands and Upper San Jacinto Bay. A review of the LIDAR data provided by the applicant and FEMA map showed the wetlands outside of the FEMA 100-year floodplain of Upper San Jacinto Bay. There are no confined hydrologic connections between the wetlands and any water of the United States determined by on-site and off-site data. The wetlands are not adjacent to any waters of the United States as defined by 33 CFR 328.3(c).

Wetland1 and Wetland2 are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Isolated waters are defined in 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable waters of the United States; and (2) Not adjacent to such tributary waterbodies.

Wetland1 and Wetland2 are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea.

They do not cross interstate or tribal boundaries. Wetland1 and Wetland2 do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. These wetlands are not impoundments of waters of the United States. Wetland1 and Wetland2 are not, nor were they ever, part of a surface tributary system of previous waters. These wetlands are not adjacent to any other waters previously identified. Wetland 1 and Wetland2 have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this geographic region that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**



Two isolated wetlands totaling approximately 1.7 acres (Wetland1 approximately 0.3 acre & Wetland2 approximately 1.4 acres) identified on the subject property are surrounded by uplands. The wetlands were identified using the Atlantic and Gulf Coastal Plain Region Supplement of the 1987 Corps of Engineers Wetland Delineation Manual which under normal circumstances exhibits a dominance of hydrophytic vegetation, wetland hydrology indicators, and hydric soils. The nearest water of the United States is Upper San Jacinto Bay, a traditional navigable water subject to the ebb and flow of the tide and is used to transport interstate commerce. Wetland1 is located approximately 1200 feet south of Upper San Jacinto Bay. Wetland2 is located approximately 1400 feet south of Upper San Jacinto Bay.

Based on the site visit conducted 10 February 2017, there are no known hydrological connection between the wetlands and Upper San Jacinto Bay. A review of the LIDAR data provided by the applicant and FEMA map showed the wetlands outside of the FEMA 100-year floodplain of Upper San Jacinto Bay. There are no confined hydrologic connections between the wetlands and any water of the United States determined by on-site and off-site data. The wetlands are not adjacent to any waters of the United States as defined by 33 CFR 328.3(c).

Wetland1 and Wetland2 are isolated and are not waters of the United States, as defined in 33 CFR 328.3(a). Isolated waters are defined in 33 CFR 330.2(e) as those non-tidal waters that are: (1) Not part of a surface tributary system to interstate or navigable waters of the United States; and (2) Not adjacent to such tributary waterbodies.

Wetland1 and Wetland2 are not currently used, were not used in the past, nor are they susceptible to use in interstate or foreign commerce. They are not subject to the ebb and flow of the daily tide, nor are they part of a territorial sea. They do not cross interstate or tribal boundaries. Wetland1 and Wetland2 do not affect (i) interstate or foreign travelers for recreational purposes or other purposes or, (ii) fish or shellfish that could be taken and sold in interstate or foreign commerce or, (iii) current use or potential use for industrial purposes by industries in interstate commerce. These wetlands are not impoundments of waters of the United States. Wetland1 and Wetland2 are not, nor were they ever, part of a surface tributary system of previous waters. These wetlands are not adjacent to any other waters previously identified. Wetland 1 and Wetland2 have been determined not to be "ecologically adjacent", as defined in the Rapanos guidance as being "reasonably close" such that an ecologic interconnectivity is beyond speculation or insubstantial. There are no known species in this geographic region that require both the subject wetlands and the nearest waterbody (a water of the United States other than an adjacent wetland) to fulfill spawning and/or life cycle requirements.

In conclusion, it is SWG draft determination that the two wetlands on the tract totaling approximately 1.7 acres are are isolated (as per federal regulation) wetlands that do not possess any known nexus to interstate commerce. As such, are not subject to federal regulation under Section 404 of the Clean Water Act
