Explain: HCFCD Unit K163-00-00 was characterized within the review area. The waterbody is an excavated drainage ditch cretaed to drain nearby neighborhoods and upland areas to reduce flooding. Based on topography, aerial imagery, and visual observations, surface water flows into the drainage ditch from surrounding neighborhoods and upland areas with sufficient hydrology to produce an OHWM. HCFCD Unit K163-00-00 was characterized using

methodology set forth in Regulatory Guidance Letter 05-05 and the HCFCD Ordinary High Water Mark Delineation Manual for Section 404 Waters. The waterbody is a channelized drainage ditch that flows to the northwest directly into Cypress Creek (HCFCD Unit K100-00-00). HCFCD Unit K163-00-00 is a man-made channel that is directly connected to Cypress Creek which is considered a Water of the U.S. The original design of the conveyance was not intended to treat stormwater or control sediments and does not have a significant impact on moderating the chemical integrity of downstream Waters of the U.S. The waterbody lacks an outfall structure, which creates jurisdictional backflow below the OWHM of Cypress Creek into HCFCD Unit K163-00-00. Furthermore, backflow from Cypress Creek below its OHWM is expected to be limited based on flow direction and characteristics witnessed when conducting the delineation. Jurisdictional backflow below the OHWM of Cypress Creek is determined to extend approximately 150 feet upstream of the confluence of HCFCD Unit K163-00-00 and Cypress Creek.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** HCFCU Unit K163-00-00 was characterized within the review area. The waterbody is an excavated drainage ditch cretaed to drain nearby neighborhoods and upland areas to reduce flooding. Based on topography, aerial imagery, and visual observations, surface water flows into the drainage ditch from surrounding neighborhoods and upland areas with sufficient hydrology to produce an OWHM. HCFCU Unit K163-00-00 was characterizeed using methodology set forth in Regulatory Guidance Letter 05-05 and the HCFCU Ordinary High Water Mark Delineation Manual for Section 404 Waters. The waterbody is a channelized drainage ditch that flows to the northwest directly into Cypress Creek (HCFCU Unit K100-00-00).

HCFCU Unit K163-00-00 is a man-made channel that is directly connected to Cypress Creek which is considered a Water of the U.S. The original design of the conveyance was not intended to treat stormwater or control sediments and does not have a significant impact on moderating the chemical integrity of downstream Waters of the U.S. The waterbody lacks an outfall structure, which creates jurisdictional backflow below the OWHM of Cypress Creek into HCFCU Unit K163-00-00. Furthermore, backflow from Cypress Creek below its OWHM is expected to be limited based on flow direction and characteristics witnessed when conducting the delineation. Jurisdictional backflow below the OWHM of Cypress Creek is determined to extend approximately 150 feet upstream of the confluence of HCFCU Unit K163-00-00 and Cypress Creek.
