This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: Under Section 404 of the Clean Water Act (Section 404), the Corps regulates the discharge of dredged or fill material into waters of the United States (U.S.) including tidal waters. Under Section 10 of the Rivers and Harbors Act (Section 10), the Corps regulates work and/or structures in navigable waters of the United States, including tidal waters. The East End Lagoon is subject to the ebb and flow of the tide and is a navigable water of the U.S. subject to Section 10 and Section 404. Also, any wetlands adjacent to the East End Lagoon are waters of the United States subject to Section 404, if above the mean high water of the tidal canal, or subject to Section 10 and Section 404 if below the mean high water of the lagoon. The subject site off of Boddeker Road abuts a tidal water, therfor is adjacent to a TNW.
