review area with no special aquatic sites, including wetlands, associated with them (Ditch A (0.14 acre) and Ditch B (0.16 acre)). Both ditches only drain uplands and do not reroute or extend the lateral limits of our jurisdiction.. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41217), states, "For clarification, it should be noted that we generally do not consider the following waters to be Waters of the United States...(a) non-tidal and irrigation ditches excavated on dry land."

Aerial photographs depict a 3.0-acre settling pond (Pond A) excavated from uplands in 1995 in the western portion of the review area with no apparent surface connection to the previously noted drainage ditches. Just east of Pond A is a 0.16-acre pond excavated from uplands (Pond B). Both of these ponds appear to be associated with the nearby water treatment plant. The preamble for 33 CFR 328, published in Federal Register Volume 51, Number 219, published November 13, 1986 (page 41250), states, "Waste treatment systems, including treatment ponds or lagoons designed to meet the requirements of CWA (other than cooling ponds as defined in 40 CFR 123.11[m] which also meet the criteria of this definition) are not waters of the United States."

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
