the tides. There are no features that have lateral limits of jurisdiction. (e.g., OHWM) Based on historical aerial imagery from Google Earth the proposed site has been used primarily for agricultural use and lacks any wetland parameters (hydric soils, hydrophytic vegetation, and wetland hydrology). Project site consists of a 7.3-acre open pit excavated to a depth of 20 to 25 feet below the ground level for borrow material. The excavated pit within the review area is being used as a stock pond for livestock.
