C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Therefore, the two tributaries have been determined to be relatively permanent.

B. ADDITIONAL COMMENTS TO SUPPORT JD: In an individual permit application submitted by Berg Oliver and Associates, dated September 21, 2016, three wetlands (Wet 1~ 4.40 acre, Wet 2 ~ 0.11 acre and Wet 3 ~ 0.07 acre), two tributaries (~ 0.32 acre), and one impoundment (~ 8.93 acre) were identified on the project site. The wetlands within the review area were identified as being part of a larger wetland complex that extends well beyond the project boundaries. The three on-site wetlands contained hydrophytic vegetation, hydrologic indicators, and hydric soils, indicative of wetlands in accordance with the 1987 Corps Wetland Delineation Manual. These wetlands are mapped on the National Wetland Inventory maps, and are within the mapped 100 year floodplain. The larger wetland on the east side of the property, directly abuts, encompasses, and is contiguous with portions Harpers Horsepen Branch and Carters Slough. Therefore, the on-site wetlands, have been determined to be subject to the Corps jurisdiction under Section 404 of the Clean Water Act. The two tributaries contain ordinary high water marks, bed and banks, and are relatively permanent waters. Harpers Horsepen Branch flows directly into Carters Slough which flows directly into West Fork San Jacinto River, a Traditionally Navigable Water. The unnamed tributary was excavated out of mapped wetlands and serves as the conduit to impound water from Harpers Horsepen Branch to the 8.93 acre impoundment area. This impoundment to the east of Harpers Horsepen Branch, was excavated out of wetlands also mapped on the USGS topographic maps (present map, 1979, and 1961) and is hydrologically connected to Harpers Horsepen Branch through the unnamed tributary. All of the aquatic features, within the review area are located within the floodplain of Harpers Horesepen Branch and/or Carters Slough. All of the identified aquatic features located within the review area have been determined to be within the jurisdictional boundaries of the United States Army Corps of Engineers. All of these aquatic resources are thereby subject to regulation under Section 404 of the Clean Water Act.
