### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: 2. Based on an examination of the data and information submitted, the proposed work will not impact any areas subject to our jurisdiction and thus, no permit required. The historical topos and aerials indicate this ditch is an upland ditch constructed prior to 1920. There is no evidence on the historical data that the ditch replaced or was constructed in a water of US. Based on geo-spatial data and historical topos, the OHWM of Sims Bayou does not extend into C148-00-00. There is an approximate 10-12 foot elevation difference at the confluence of Sims Bayou. Therefore, based on the data, the proposed project site will not impact any waters of the United States and therefore, no permit is required.
