C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Water was observed in the unnamed tributary to Boggy Creek in all of the available Google Earth aerial images, except for the 2011 image. In the 2011 image, it appears the portion of the unnamed tributary to Boggy Creek just north of the site was temporarily filled in as part of a channelization process causing the portion of the unnamed tributary to Boggy Creek on the site to be cutoff from the north. It appears the connection has been restored in the 2013 Google Earth aerial image. Field observations confirmed a semi-sinuuous flow**

regime of the feature. The feature is fed by direct precipitation and stormwater runoff from the surrounding areas. Flowing water was observed in the unnamed tributary to Boggy Creek during our 24 February 2017 site visit.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Based on our 28 February 2017 site visit and a review of on and off-site data associated with this request, we have determined that the project area contains waters of the United States, specifically the unnamed tributary to Boggy Creek. The unnamed tributary to Boggy Creek is a Relatively Permanent Water (RPW) which flows into Pine Island Bayou, a Traditional Navigable Water (TNW). Therefore, the unnamed tributary to Boggy Creek is a water of the United States subject to the U.S. Army Corps of Engineers (USACE) jurisdiction under Section 404 of the Clean Water Act (CWA). Under Section 404, a Department of the Army permit is required prior to the discharge of dredged and/or fill material into this jurisdictional water.
