This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Within the proposed 113-acre TAMU-McAllen Campus, there was an elevated irrigation canal that split the proposed site in half. In recent aerials work has been conducted and rerouted the canal to the west of the proposed TAMU-McAllen site. This canal is identified on historic USGS topographical maps as an elevated canal. The water source is located at a pumping station next to the Rio Grande. The pumping station pumps water form the Rio Grande into the elevated canal which conveys the water towards the proposed TAMU-McAllen Site. The canal is an elevated canal that is manmade, excavated from dryland, and is not a water of the US. The proposed 113-acre TAMU-McAllen campus is located wholly in dryland and is not a water of the US.
